S.B. 192 RELATING TO IDENTIFICATION CARDS

Senate Committee on Human Services and Housing

The Hawaii Department of Transportation supports this bill with the recommended amendments that requires a fee waiver for the issuance of a civil identification card to a homeless person, provided homeless status is verified with an official letter.

We would recommend the following amendments to this bill:

Amending section (2) of 286-309 to read as follows, "A new identification card as a result of an error correction or change pursuant to section 286-306(b), to a qualified individual who is homeless, subject to verification of the homeless status of the individuals by official letter from a homeless service provider <u>and the homeless service</u> <u>provider permits the homeless individual to use the homeless service provider's address</u> to the extent necessary to satisfy the requirements of the applicable federal law. ..."

Amend Section 5 to read as follows, This Act shall take effect on January 5, 2016. Implementation of this measure may require evaluation, drafting and holding of public hearings for administrative rules needing implementation as well as mainframe modifications by the City and County of Honolulu's Department of Information Technology.
