**TESTIMONY IN SUPPORT OF SENATE BILL 2083** 

A BILL FOR AN ACT RELATING TO THE STATEWIDE TRAFFIC CODE

Honorable Chairs, Keith-Agaran and Tokuda, Honorable Vice-Chairs Shimabukuro and Dela Cruz, and members of the Committees on Judiciary and Labor, and Ways and Means, the Office of the Prosecuting Attorney, County of Hawai'i submits the following testimony in support of Senate Bill No. 2083.

This measure prohibits smoking in a motor vehicle in which a minor is present.

Many restrictions are placed on drivers' behaviors; these are justified as protection of the public health and safety. The motivation to protect children from secondhand smoke and vapor from Electronic Smoking Devices in vehicles are valid extensions of this principle.

Other states have demonstrated that such regulations are valid and also enforceable. Across the nation, seven states have passed laws to prohibit smoking when children and young people are present – this year, 12 additional states are considering similar legislation. Passage of the Bill will show that Hawaii can continue to be an example for other states in the nation in promoting safe, clean, smoke-free, and healthy environments for our residents and families.

For the foregoing reasons, the Office of the Prosecuting Attorney, County of Hawai'i supports the passage of Senate Bill No. 2083. Thank you for the opportunity to testify on this matter.



#### SB2083 RELATING TO THE STATEWIDE TRAFFIC CODE.

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> SB2083, which prohibits smoking in a motor vehicle in which a minor is present. This bill may help to significantly decrease the rates of smoking and its associated chronic diseases, including the adverse health effects associated with childhood second-hand smoke exposure.

OHA's strategic priorities include Mauli Ola (Health), which represents our commitment to improve the conditions of Native Hawaiians and their quality of life by improving family lifestyle choices and reducing the onset of chronic diseases. Consistent with this strategic priority, OHA supports tobacco use reduction efforts, such as that proposed in this measure. Smokers and those chronically exposed to secondhand smoke are at increased risk for a plethora of medical conditions, including heart disease, stroke, respiratory ailments, diabetes, eye disease, dental problems, and arthritis. Tobacco smoke can also trigger asthma and increase blood pressure due to damaged blood vessels.<sup>1</sup> Preventative measures to reduce tobacco use and the harmful effects of secondhand smoke are particularly important for Native Hawaiians, as Native Hawaiian adult and youth tobacco use rates are significantly higher than the state average.<sup>2</sup>

By prohibiting smoking in cars in which a child is present, this measure may directly reduce both the rate of smoking among adults with children, as well as the rate of childhood second-hand smoke exposure. In addition, the enactment of the proposed prohibition may serve to educate all residents regarding the dangers of second-hand smoke exposure to children. Notably, seven states, along with Puerto Rico and Guam, have already passed similar legislation prohibiting adults from smoking in a motor vehicle when a child is present.

Accordingly, OHA urges the Committee to **PASS** SB2083. Mahalo nui for the opportunity to testify on this important measure.

Hrg: March 1, 2016 at 10:30am at Capitol Room 211 As a pediatrician and medical director of the HEALTHY Quit Smoking Program at Kapi'olani Medical Center for Women & Children, I strongly support SB 2083, which encourages the State of Hawai'i to prohibit smoking in a motor vehicle when a minor is present. I have seen children come to our clinic and hospital with asthma exacerbation, pneumonia, bronchitis, middle ear infection, and other health issues that are worsened by exposure to secondhand tobacco smoke.

Children do not have a choice when they are placed in cars with smoking adults, and therefore are forced to inhale toxins that affect their health. This exposure affects them significantly, even if the car windows are open. Tobacco smoke and byproducts cling to the car's interior and to the child's hair, skin, and clothing. Allowing smoking in cars with children is the equivalent of putting a child in the space the size of a closet and then lighting a grill in that same space.

Electronic cigarettes and vaping devices should also be included in these regulations, too. Electronic smoking devices take a mixture of chemicals, including nicotine, and vaporize it at high temperatures. These devices emit nicotine byproducts and a variety of other chemicals, and they have not been fully studied in regards to safety. E-cigarette vapor has been shown to include carcinogens and toxins including nicotine, nitrosamines, diethylene glycol, formaldehyde, and acetaldehyde. The U.S. Food and Drug Administration has exhibited concern regarding the safety of electronic smoking devices as well.

Hawai'i has been a leader, protecting the public and its visitors from the dangers of secondhand smoke, and now, the State Legislature has the opportunity to protect its children and young people from the harmful impacts of smoking in a vehicle. Across the nation, seven states have passed laws to prohibit smoking when children and young people are present. This year, 12 additional states are considering similar legislation. We hope that Hawai'i can continue being an example for other states in the nation in promoting clean, smoke-free, and healthy environments for our residents and families by passing SB 2083.
