#### RELATING TO ABSENTEE BALLOTS

January 29, 2016

Chair Keith-Agaran and members of the Senate Committee on Judiciary and Labor, thank you for the opportunity to testify in support of Senate Bill No. 2117. The purpose of this bill is to authorize the electronic transmission and return of absentee ballots by voters, within five days of an election.

This bill addresses situations in which a voter has not received a ballot, needs a replacement ballot, or otherwise is not able to return their ballot to election officials by the close of polls. Under the current law, HRS § 15-5(d), beginning with the fifth day prior to an election, the only voters that are covered in such a situation are military and overseas voters, who are covered by the protections of chapter 15D, HRS (i.e., the Uniform Military and Overseas Voters Act).

For all other voters, such as voters who are on the mainland due to a family emergency, or someone at college who has spoiled their ballot, there is no other option other than to mail them a ballot, which they may not receive in time to vote and return to election officials by election day.

As such, the present bill proposes to take advantage of changes in technology and allows ballots to be electronically transmitted to and returned by voters within five days of an election. This would benefit not only the traditional military and overseas voters who may be in remote locations with limited mail service and fax service, but also regular voters who due to circumstances beyond their control are not able to receive and return a ballot by mail in close proximity to an election.

# TESTIMONY OF JADE K. FOUNTAIN-TANIGAWA COUNTY CLERK, COUNTY OF KAUA'I TO THE SENATE COMMITTEE ON JUDICIARY AND LABOR ON SENATE BILL NO. 2117 RELATING TO ABSENTEE BALLOTS

Chair Keith-Agaran and Committee Members:

Thank you for the opportunity to testify in support of Senate Bill No. 2117. This Bill as proposed allows a permanent absentee ballot voter the ability to receive ballots at an alternate address for elections within an election cycle. Additionally, the Bill would define "electronic transmission" and allow for such transmission of absentee ballots within five (5) days of an election for voters who have not received or who require a replacement ballot. Allowing the electronic transmission of ballots provides a practical and expeditious means for casting a ballot and is consistent with our overall efforts to maximize voter participation.

Currently, statutes governing the Permanent Absentee Ballot (PAB) voting process are silent regarding PAB voters who request to have their ballots temporarily mailed to an alternate address which differs from the address contained in the voter's file. Although County election officials have developed an administrative process to address this situation, this Bill clarifies and codifies the established practices.

Thank you for this opportunity to testify in support Senate Bill No. 2117.

#### TESTIMONY

Janet Mason, Co-Chair, Legislative Committee, League of Women Voters of Hawaii

Chair Keith-Agaran, Vice-Chair Shimabukuro, and Committee Members:

The League of Women Voters of Hawaii supports SB2117 that permits a permanent absentee voter to receive a ballot someplace besides their permanent residence address within an election cycle. The bill also makes it clear that certain conditions that would normally result in terminating "permanent absentee" voting status are irrelevant if the voter resides in an absentee voting only area. It modernizes the language of electronic voting to broaden the reference to "facsimile" ballots, and provides that the voter can receive an electronic ballot, if election day is imminent or the voter can't return their properly issued absentee ballot before the polls close.

This measure is more than election administration housekeeping because it's also making clear to the permanent absentee voter what he/she can (and should) do for their ballot delivery address in the event they expect to be temporarily away from Hawaii.

Thankfully, it also speaks to what can be done if a permanent absentee voter does not receive a mailed ballot, or has lost or destroyed their ballot. Under these circumstances electronic ballot transmission is the only practical approach; this is the way we live and work now. Our understanding is this method is already well established for Hawaii residents who are serving in the military overseas.

All of these procedures become more important as the popularity of voting by mail increases. We urge you to pass this bill. Thank you for the opportunity to submit testimony.
