My name is Maile Kanemaru and I am current the Director of Weed and Seed. I am testifying in support of SB 2182

Weed and Seed is a Program sponsored by the United States Attorney's Office for the District of Hawaii. We have been in existence for the past 18 years. Weed and Seed was a Program of the Department of Justice from 1991 - 2012. Although no longer part of DOJ, the communities of Kalihi/Plama/Chinatown, Waipahu and Ewa/Ewa Beach continue to support the Weed and Seed Programs and participate in many of the activities.

The four components of Weed and Seed are 1) law enforcement 2) Community Policing 3) Prevention/Intervention and Treatment/ and 4) Neighborhood restoration (which includes community blight and education)

The principles by which we operate are: Community participation, Coordination (avoid duplication), Collaboration (no one entity can do it alone) and leveraging (many resources are needed to keep a community safe.)

Weed and Seed has been the bridge between law enforcement and community. Through the Weed and Seed activities, the police officers and residents have become partners in working together in planning and implementing strategies in keeping their community safe.

Each community has a Steering Committee made up of volunteers who meet monthly that in 2015, provided 2,304 hours of advisory support. This has resulted in a value of \$51,056.

Through the four Weed and Seed components, stakeholders take an active role in clean up campaigns and community activities and events rather than rely on government or other entities to keep their neighborhoods safe and clean. In 2015 a total of 10,425 volunteers put in 1,981 hours for a value of \$6,050,000. Most of the properties for clean ups and graffiti paint outs are government properties. A total of \$67,563 were also solicited as in kind goods and services.

Weed and Seed has educated individuals on how drugs and other negative influences ruin families and community. Weed and Seed has empowered residents to take back their community. The residents are no longer afraid to call 9-1-1 to ask for help. As the saying goes, "Ohana means no one is left behind." I believe that because of Weed and Seed, no one in Waipahu is left behind.

Aloha Chair Nishihara, Vice Chair Espero, and other distinguished committee members

Thank you for allowing me to testify on behalf of this proposed amendment. My name is Aaron Hunger and I am a doctoral researcher at the University of Hawaii at Manoa, a former police officer in Florida and California, and a criminal justice instructor for a private college in Honolulu. I have been honored to be engaged in doctoral research involving the Honolulu Police Department, and its oversight mechanisms since 2010. Together with my teaching, I have over 24 years of police experience. Currently, I am engaged in research with the University of Hawaii at Manoa that (among other issues) seeks to understand the unique structure of the criminal justice institutions on Oahu. Based on the unique composition of local policing organizations, one of many questions being answered is what effect (if any) does the absence of critical systemic oversight mechanisms (or their dysfunctionality) produce and how often. Based on the work and research that I have been privileged to be a part of, I would support Senate Bill 2182 (Expansion of Weed and Seed Program).

Support for this bill is based on the evidence gathered from law-makers, local politicians, federal oversight agencies, and community lobbyists and activists, all of whom point to a loss of trust in police services and accountability (statewide.)¹ Loss of trust between police and their communities is not a new, nor is it a minor issue. Communal trust in how police services are applied and distributed is critical in allowing the government to remain "legitimate" in the eyes of its citizens. Due to the high number of Honolulu police (and other law enforcement agencies throughout the state) who have been caught and prosecuted for gross violations of departmental policies and criminal statutes, addressing these communal concerns over governmental authority and "legitimacy" becomes a matter of national security and legislative priority.

Should there be a breakdown of social order as a result of police abuses of authority and power, the fiscal and political ramifications would be significant. Criminologists, community groups, and legislators have agreed that community style policing models have been specifically designed to address communal-police trust problems, which have been ongoing in most minority community's thought-out major U.S. cities.² One philosophical difference between the methods and practices used in Weed and Seed (aka community style policing) and those used in traditional routine patrol is that Community Police Officers are trained to think of themselves as service providers whose primary tool is critical

thinking, while traditional police training centers around maintaining control (often through the use of physical force.)³

Community style police programs (like Weed and Seed) had experienced a surge in funding and interest in the years leading up to September 11th, 2001. However, after the terror attacks in New York City, priorities for police changed.⁴ After it became clear to Homeland Security experts that domestic terrorism and terrorism initiated by covert embedded cells (both) posed a significant risk to national security, local police were reorganized into fusion center clusters. ⁵ These national fusion centers were responsible for coordinating training and standards for local law enforcement to ensure that local policing agencies were able to achieve an operational interconnectivity with federal law enforcement agencies. What became noticeable was the militarization of police that occurred during this criminal justice national strategy shift.⁶

Restoring funding for the Weed and Seed program sends the message to police managers that the shifts that took place away from communal centrism of police, should be undone, and that priorities and strategies for policing should shift back towards "policing with Aloha". Community style policing (or Weed and Seed) is the idea of weeding out the bad elements of a community, and seeding in good programs. The weed and seed programs are designed to bolster alternatives to incarceration or imprisonment options, especially when focusing on juvenile delinquents.

Weed and Seed programs in Chinatown have been successful according to Weed and Seed officers who were assigned to the program. When interviewing these officers, they explained that the two major obstacles to the program's success were the lack of funding, and the lack of seriousness with which their own command staff and officers viewed the program. While the funding for this program can be addressed with this bill, a change in police culture must also take place. It is my recommendation, therefore, that this bill be amended to include mandatory departmental (and management) retraining on community style policing and the important role it has in rebuilding communal trust in government.

Unfortunately, police themselves must reach the understanding that they are their own worst enemies, when it comes to public image. While police see their conduct or actions as creating the greater good, it often comes as a result of using tactics that alienates the very communities they seek to serve. By expanding this bill to include mandatory community style police retraining for the entire department (and specifically for departmental managers) the bill's intent will be strengthened. Community style policing models operate, and must be managed differently than traditional patrol style models. This is because community style policing uses inverse management tools (an upside down power pyramid) where the community officer is at the top of the pyramid of power, while the chief is at the bottom.⁷

With statewide police organizations being spotlighted by the media as becoming more distinct from the communities they serve by imaging themselves as overseers and domestic warrior-hunters, communities are beginning to demand action by their legislators to seek relief from over-exuberant police who use force rather than critical thinking skills to solve problems. The evidence and data that exists surrounding police community relations in Hawaii, strongly suggests that this bill be enacted to begin to address mounting frustration and loss of trust towards local police departments and their agents by their communities.
