SUBJECT: Support for SB2196 Law Enforcement Officer Independent Review Board Suggestions for Amendments

I encourage the Committees to approve SB 2196 to establish a Law Enforcement Officer Independent Review Board. I recognize that law enforcement is a high stress, sometimes dangerous occupation and have sympathy with officers who must sometimes make split-second decisions. However, the lack of transparency within the law enforcement community and a number of incidents in which police officers have killed or injured people while in their custody or during an arrest attempt, has unfortunately resulted in a steep decline in public trust of law enforcement officers. This is a problem for the entire community, since we depend on these people to protect us and need to be able to trust them.

Hawaii does not have capital punishment. However, in recent years police officers have killed members of the public for not obeying police orders, for driving away from a traffic stop, and for other reasons which would never carry the death penalty, even if the state had one. In one recent year, Honolulu was reported as having one of the highest "kill" rates in the country! Whether true or not, in the public eye, these officers have not been held accountable for these deaths. Names are withheld and the public has no knowledge of punishment that may have been imposed. More importantly, those responsible have only rarely been charged with a crime and come before the law to be judged guilty or not-guilty, as are members of the general public.

SB2196 alone will not solve all these problems. However, setting up an independent review board with the power to refer officers to the Attorney General for possible prosecution will go a long way toward reassuring the public that law enforcement officers are not above the law. At the same time, it may go a long way toward restraining over-reactions in tense situations by reminding officers that they serve the public and are also subject to the law.

I suggest two amendments to this bill:

- 1. Amend, throughout the bill, the phrase "deaths while in custody" by adding "or in the course of any law enforcement action." The current wording seems to exempt deaths that occur during the arrest process or during actions surrounding attempted arrests.
- 2. Clarify who "an independent review board investigator" is [28-C (c)]. A single member of the Board? Someone appointed by the Board? If appointed, what the qualifications of this person must have?

I urge you to support SB2196.
