Chairs Chun Oakland and Harimoto and Members of the Committees:

The Department of the Attorney General provides the following comments.

The purpose of the bill is to appropriate \$1 for fiscal year 2016-2017 to the Department of Human Services (DHS) to develop prevention and intervention programs to target youth who are at high risk of engaging in gang activities or of joining youth gangs.

Article III, section 14, of the Hawai'i Constitution provides in part: "No law shall be passed except by bill. Each law shall embrace but one subject, which shall be expressed in its title." The title of this bill, "Relating to Youth Gang Prevention and Intervention," arguably expresses two subjects—youth gang prevention and youth gang intervention. Indeed, the bill requires the DHS to develop programs that both help prevent youth from joining gangs and help intervene in the lives of youth who engage in gang activities. Because the bill appears to include two subjects in its title, the bill may be subject to challenge as violative of article III, section 14, of the Hawai'i Constitution. We suggest this problem could be cured by providing an explanation in section 1 as to why "prevention and intervention" actually constitute a single subject. If this explanation cannot be made and there are really two subjects, we recommend that another vehicle with a title such as "Relating to Youth Gangs" or "Relating to Human Services" be used to enact the appropriation proposed by this bill.

We respectfully ask the Committee to make the suggested amendments or to hold this bill.

OFFICE'S POSITION: OYS supports the intent of the measure but requests that any appropriation not affect the priorities in the Executive Biennium Budget. OYS agrees that many factors can contribute toward an apparent increase in graffiti, violence, substance abuse and criminal activities. Risk factors such as poverty, higher concentrations of immigration, lack of parental guidance and supervision, and social disorganization in the community can negatively impact a community and its ability to respond to an apparent youth gang problem. Careful analysis of the extent and depth of the type of criminal activity, and apparent symptoms of underlying social and economic dynamics is required prior to committing valuable resources toward any initiative related to our State's at-risk and troubled youth.

OYS supports a balanced and multi-prong approach to strengthen and improve a community's response in addressing any problem affecting a community. Currently, prevention and intervention efforts are underway through ongoing partnerships with various resources such as the police, Department of Education, Judiciary, community-based agencies, and the University of Hawaii, to address problems such as increased criminal activities that may be more related to ethnic and geographic concerns rather than a strict definition of gang activity.

Chair Chun-Oakland, Chair Harimoto, Vice-Chair Riviere, Vice-Chair Galuteria and members of the Senate Committee on Human Services and Housing, the Department of the Prosecuting Attorney of the City and County of Honolulu ("Department") supports the intent of S.B. 2211, however, would urge this committee to consider reallocating the funds associated with S.B. 2211 to Adult Friends for Youth as an alternative agency to carry out the goals and objectives.

The purpose of S.B. 2211 is to help reduce the growing youth gang problem in the State by creating programs aimed to promote education, self-esteem, individual growth and development, leadership, and responsibility. The creation of additional programs to assist our youth is consistent with this Department's ongoing concern for at-risk youth and the rise of youth gang affiliation. Over the years, our Department has seen increases in crime involving youth offenders who at times are as young as 12 years of age. Yet, despite this rise, there are few programs available to youth offenders in Hawaii, often leaving them with little or no meaningful alternatives.

While the purpose of S.B. 2211 is to establish a multi-pronged approach in programs which aim to target at-risk youth who reside in the public housing, our Department would strongly urge this committee to consider appropriating funds associated with S.B. 2211 for the fiscal year 2016-2017 to Adult Friends for Youth as an alternative. Adult Friends for Youth, was established in 1985 at the University of Hawaii, School of Social Work and boasts a stellar track record and history of sustainability which would ensure that any appropriated funds will be

allocated properly and effectively. Adult Friends for Youth works with more than 400 high risk youth per week and has established many successful programs such as their Re-directional Therapy which is an effective therapeutic approach to combat violence, drugs, crime, teen pregnancy, family dysfunction, learning disabilities and anti-social behaviors amount the very high risk youth both in and outside of the classroom. Through the programs implemented by Adult Friends for Youth, their services have successfully changed the attitudes and behaviors of over numerous different gangs. They have also successfully assisted multiple gang members through the difficult task of integration back into the community.

For all the reasons above, the Department of the Prosecuting Attorney of the City and County of Honolulu supports the intent of S.B. 2211 and strongly urges this committee to reallocate any funds to the Adult Friends for Youth Program. Thank you for the opportunity to testify on this matter.
