TO CHAIRPERSON GILBERT KEITH-AGARAN AND MEMBERS OF THE SENATE COMMITTEE ON JUDICIARY AND LABOR:

Thank you for the opportunity to testify in **strong support** of S.B. 2215.

The purpose of S.B. 2215 is to appropriate funds for the hiring of six hearing officer positions and support staff within the department of labor and industrial relations' disability compensation division and to provide the officers and staff with legal and medical training.

The Department of Human Resources Development ("DHRD") has a fiduciary duty to administer the State's self-insured workers' compensation program and its expenditure of public funds.

DHRD believes that additional hearings officers and support staff, with the proper legal and medical training, will allow the Disability Compensation Division to expedite hearings and decisions on contested issues of compensability, medical treatment, and myriad other issues that arise in workers' compensation claims. This would benefit all stakeholders in the workers' compensation system.

I. OVERVIEW OF PROPOSED LEGISLATION

S.B. 2215 proposes to appropriate funds for the hiring of six hearing officer positions and support staff within the Department of Labor and Industrial Relations' (department) Disability Compensation Division (DCD) and to provide the officers and staff with legal and medical training.

The department does not object to this measure provided that its passage does not replace or adversely impact priorities indicated in our Executive Budget. The FY 17 Executive Budget proposal already contains the following requested positions in DCD:

- 1 Professional Employers Organization Specialist
- 1 Vocational Rehabilitation Specialist
- 2 DC Enforcement Specialists (1 in Kauai; 1 in Kona)
- 1 Auditor

II. CURRENT STATUS

The Disability Compensation Division is currently in a rebuilding process after

suffering 31% of its staff positions being cut since 2009. In 2013, the legislature authorized 14 positions (while abolishing three other positions) and in 2014 authorized one additional position to DCD's staff.

The 2015 legislature appropriated \$905,000 to conduct a business process optimization analysis and case system modernization for the Disability Compensation program. A consultant (Gartner) was contracted to: conduct the Disability Compensation Business Process Optimization Study; and to develop a DC Program Business Case. In the past five months, the contractor has been working on a wholesale review of DCD's current processes, organization, and technology. The contractor is currently developing the Business Case/Modernization plan to execute the recommended process changes identified in their review.

Until the case system modernization project is completed, DCD will be implementing low/no cost changes addressed in the contractor's study. The big improvements will come with the modernization of the DCD program, but those gains will not be realized until FY 18 and FY 19.

DCD is still struggling with its current system and is currently taking up to eight weeks to establish a Workers' Compensation (WC) claim and up to six months to schedule a hearing. Temporary Disability Insurance (TDI) hearings, although fewer in number, are backlogged 3 years in Honolulu and as much as 7 years on the Neighbor Islands.

III. COMMENTS ON THE SENATE BILL

The department appreciates the opportunity to increase its DCD staff to improve its quality and timeliness of services to the public and has no objection to this measure, provided that its passage does not replace or adversely impact priorities indicated in our Executive Budget as referenced in the Overview Section of this testimony.
