Fiscal Implications: The Department of Health defers to the Governor's Supplemental Budget
 Request for its fiscal priorities regarding the \$10,000 general fund appropriation proposed by
 S.B. 2317.

4 Department Testimony: The purpose of this measure is to establish a maternal mortality
5 review panel within the Department of Health to conduct a comprehensive review of maternal
6 deaths that have occurred in the State.

7 Out of an average 19,000 births per year, between zero and ten maternal deaths are documented 8 each year. The proposed \$10,000 appropriation is likely insufficient to implement and sustain a 9 meaningful maternal mortality review panel whose responsibilities and scope would include 10 report writing, promulgation of administrative rules and management of contested case hearings, and coordination of communications and policy development to effect necessary environmental 11 12 and systems changes. The Department respectfully recommends the combined maternal and child mortality framework proposed in S.B. 2234 and the composition of maternal mortality 13 14 review representatives, statutory changes, and immunity protections in S.B. 2317 as a foundation for a coordinated public approach to address local systems and policies to improve maternal and 15 16 child health.

On behalf of the Hawaii State Commission on the Status of Women, I would like to express my support for SB 2317, which would establish a maternal mortality review panel to review maternal deaths in Hawaii.

The Centers for Disease Control (CDC), the American Congress of Obstetricians and Gynecologists, the World Health Organization, and the Association of Maternal & Child Health Programs, among many other organizations, strongly recommend that all states have a formal review process of maternal deaths to decrease maternal mortality and morbidity. Hawaii does not review maternal deaths, despite having a maternal mortality ratio of anywhere between 9-14 deaths per 100,000 live births.

According to the World Health Organization, 47 countries had lower maternal mortality ratios than the U.S. Nationally, women of color have a higher maternal mortality ratio than white women (CDC, NCHS). Yet, no similar data is currently publicly available or analyzed for Hawaii's multiethnic population.

Maternal mortality reviews highlight possible areas for system improvements and changes that can lead to better pregnancy care for all women and have been proven to work in other states and countries. Establishing a maternal mortality review panel will undoubtedly save lives. The panel would require a very small appropriation (under \$10,000). The Commission supports this measure and respectfully requests that you pass this bill. Thank you for hearing this important measure. The Hawaii Public Health Association (HPHA) is an association of over 600 community members, public health professionals, and organizations statewide dedicated to improving public health. HPHA also serves as a voice for public health professionals and as a repository for information about public health in the Pacific.

HPHA **supports the passage of SB2317** which establishes a Hawaii Maternal Mortality Review Panel within the DOH to conduct a comprehensive review of maternal deaths that have occurred in the State.

Hawaii is currently ranked at 37th for maternal mortality in the US. Between 2001-2006, the maternal mortality ratio was estimated by the CDC as 13.9 deaths per 100,000 live births in Hawaii. Maternal Mortality Review Panels (MMRP) have been shown to decrease maternal mortality and increase the quality of care for all women. Establishment of an MMRP will enable identification of factors associated with maternal deaths, provide data to for establishment of preventative services and programs, and improve current methodology in delivery services and overall maternal care.

Further, an MMRP can identify the training needed in order for health care providers to react and provide care in severe situations during childbirth such as hemorrhage, venous thromboembolism, and severe hypertension. The MMRP will review these cases where death or near death occurs and provide examples and alternatives so that safety is ensured

in the future. These actions can therefore influence regulations and system changes to improve reaction times and performance during procedures.

HPHA supports the establishment of an MMRP that will identify system changes leading to decreased maternal mortality and provide the much needed quality of care for all women.

Thank you for considering our testimony concerning **SB2317**, which would establish a Hawaii Maternal Mortality Review Panel within the DOH to conduct a comprehensive review of maternal deaths that have occurred in Hawaii.
