Family Therapists Program ("Program"), Professional and Vocational Licensing Division

of the Department of Commerce and Consumer Affairs ("Department"). Thank you for

the opportunity to present testimony on Senate Bill No. 2333, S.D. 1.

The Department and the American Association for Marriage and Family Therapy,

Hawaii Division ("AAMFT Hawaii") had a discussion about the proposed bill and the

Program is in support of Senate Bill No. 2333, S.D. 1.

This change will align Hawaii's law with essentially all of the other states that use

the title "licensed marriage and family therapist" ("LMFT"). Also, the proposed revisions

in this bill will reduce confusion about the status of licensees who are LMFTs in Hawaii who have met the same standards as LMFTs in other states.

While the Program believes there may be benefits to this measure's proposed insertion of the term "licensed" before existing statutory references to the title "marriage and family therapists", the Program defers to the Regulated Industries Complaints Office regarding any enforcement-related concerns about these revisions.

Senate Bill No. 2333 S.D.1, in Sections 1 through 10, amends Chapter 451J, Hawaii Revised Statutes ("HRS"), to add the phrase "or licensed marriage and family therapist" after "marriage and family therapist".

As originally drafted, the bill proposed amendments to Chapter 451J, HRS, which would have narrowed RICO's enforcement authority. Senate Bill No. 2333 S.D.1 addresses RICO's enforcement concerns with the addition of the phrase "or licensed marriage and family therapist".

RICO notes that this Committee previously heard the House companion measure, House Bill No. 1629, passing out a House Draft 1 with amendments to Chapter 451J, HRS, that are substantially similar to the amendments in this bill. House Bill No. 1629 H.D.1 was not heard by the House Committee on Judiciary and did not cross over.

Thank you for the opportunity to testify on Senate Bill No. 2333 S.D.1. I will be happy to answer any questions the Committee may have.

As an LMFT in Illinois and an MFT in Hawaii, I support this bill because it would eliminate confusion in the mental health field regarding who is licensed and who is not. By having the "L" before the MFT here in Hawaii, we can better align with standards throughout the U.S. and allow our local therapists to compete for federal jobs, which often require the designation of LMFT.

Unfortunately, many employers don't understand that there is a distinct difference between a licensed marriage and family therapist and a marriage and family therapist who has not completed the licensing requirements. For those of us who have completed the rigorous licensing requirements, it's only fair that we have a way to distinguish ourselves from those who have not--or are in the process of doing so.

Having worked as a Marriage and Family Therapist in two states on the mainland, I can tell you that the "L" before the MFT is a big deal, and often makes the difference between getting a job and not getting a job. We need to be on the same page as other states, so our clients know exactly what kind of training we have.

In short, we licensed Marriage and Family Therapists have put in an extraordinary amount of work to get licensed here, and we should be able to show that to our clients without confusion. By adding an "L" to MFT, our clients will know exactly what they are getting.
