TO THE HONORABLE ROSALYN H. BAKER, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is Lynn Bhanot, and I am the Executive Officer of the Marriage and

Family Therapists Program ("Program"), Professional and Vocational Licensing Division

of the Department of Commerce and Consumer Affairs ("Department"). Thank you for

the opportunity to present testimony on Senate Bill No. 2333.

The Department and the American Association for Marriage and Family Therapy,

Hawaii Division ("AAMFT Hawaii") had a discussion about the proposed bill and the

Program is in support of Senate Bill No. 2333.

This change will align with essentially all of the other states that use the title

licensed marriage and family therapist ("LMFT"). Also, this will reduce any confusion

about licensees who are LMFTs in Hawaii who have met the same standards as LMFTs in other states.

While the Program believes there may be benefits to this measure's proposed insertion of the term "licensed" before existing statutory references to the title "marriage and family therapist," benefits which include reducing confusion amongst the public or inappropriate use or representation of titles by non-licensed members of the marriage and family therapy community, the Program also recognizes that there may be enforcement concerns related to these particular proposed amendments. As such, the Program would defer to the Regulated Industries Complaints Office regarding such concerns.

The Department of Commerce and Consumer Affairs ("Department")

appreciates the opportunity to testify on Senate Bill No. 2333, Related to Licensed

Marriage and Family Therapists. My name is Daria Loy-Goto and I am the

Complaints and Enforcement Officer for the Department's Regulated Industries

Complaints Office ("RICO"). RICO offers comments on this bill.

Senate Bill No. 2333 amends Chapter 451J, Hawaii Revised Statutes

("HRS"), to add the word "licensed" before the term "marriage and family

therapist". RICO defers to the Department's Marriage and Family Therapists

Program on the purpose and intent of the bill, but offers the following enforcementrelated comments on Sections 4 to 10 of the bill as they relate to Chapter 451J, HRS.

Currently, Chapter 451J, HRS, prohibits the use of the title "marriage and family therapist" by any person who does not possess a marriage and family therapist license. Accordingly, RICO is authorized to pursue action against any individual who uses the title without first obtaining a marriage and family therapist license.

As currently drafted, however, Senate Bill No. 2333 would narrow RICO's enforcement authority. Under the bill, RICO would only be able to enforce Chapter 451J, HRS, in situations where a person uses the title "licensed marriage and family therapist" without having the appropriate license. RICO would be unable to take any action against a person who uses the title "marriage and family therapist" when such person does not possess a license.

In reviewing Sections 4 to 10 of the bill, RICO believes that all insertions of the word "licensed" are problematic from an enforcement perspective, except on page 12, line 5, and on page 15, line 3. RICO is willing to work with the Marriage and Family Therapists Program, the professional associations, and the Committee on any amendments to the bill.

RICO notes that the House Draft 1 version for this bill's companion measure, House Bill No. 1629, adds "or licensed marriage and family therapist" to existing "marriage and family therapist" in Sections 3 through 8 and RICO believes this approach addresses its enforcement concerns.
