S.B. 2375 RELATING TO THE STATEWIDE TRAFFIC CODE

Senate Committee on Transportation and Energy

The Department of Transportation provides **comments** on S.B. 2375 to establish a 65 mile per hour speed limit for the Daniel K. Inouye highway.

The Daniel K. Inouye highway was constructed based on a design speed of 50-60 miles per hour. The safety features such as guardrail end treatments, roadway curves, stopping sight distances, intersection sight distances, etc. were designed to meet this design speed in accordance with national standards. Setting speed limits above the design speed decreases safety for all roadway users and increases liability risk to the State.

Dear Senator Inouye:

The Hawai`i Police Department strongly opposes the passage of Senate Bill 2375, relating to Transportation. The purpose of this Bill is to increase the maximum speed limit on the Daniel K. Inouye Highway from 55 mph to 65 miles per hour (mph).

Our opposition is based on what we know to be a road that is often shrouded in heavy fog, crossed by wild animals and having very steep grades in certain areas. Furthermore, our experience in enforcing traffic regulations on that road is that often we will encounter vehicles exceeding the posted speed limit by 25 mph or 30 miles per hour. Unfortunately, raising the maximum limit will in actuality encourage some of those motorists to continue to drive 25 to 30 mph over the posted speed limit, which would mean speeds close to 100 mph.

Throughout the nation, speed is often cited as a major factor in traffic fatalities and when coupled with steep grades, animal crossings, and fog would certainly tend to form a combination that threatens the well-being of the motoring public.

For these reasons and based upon our firsthand experience with this matter, we strongly urge this committee to **oppose** this legislation. Thank you for allowing the Hawai'i Police Department to provide comments relating to Senate Bill 2375.
