1 **Fiscal Implications:** None.

2 **Department Testimony:** Thank you for the opportunity to testify in SUPPORT of this bill as

3 amended.

This bill will require the relicensing or recertification inspections of care facilities to be
unannounced. The current statutes either require the relicensing inspections of Adult Residential
Care Homes (ARCHs), Expanded ARCHs (E-ARCH), and medical marijuana dispensaries to be
announced, or in the case of recertification of Community Care Foster Family Homes (CCFFH),
the statute is silent.

9 The Department prefers that relicensing or recertification surveys be unannounced in 10 order to maximize the readiness of the care homes or dispensaries for an inspection at any time 11 by the Department. This will also be consistent with all other relicensing inspections of health 12 care facilities under the regulatory responsibility of the Office of Health Care Assurance 13 (OHCA), and is seen as an improved safeguard for the public. Finally, OHCA conducts 14 recertification inspections on Medicare facilities on behalf of the federal government. The 15 federal government requires that all such recertification inspections be conducted unannounced.

1	The technical amendments requested by the Department were included in SD1, and the
2	changes in HD1 are acceptable as well. As a result, the Department remains supportive.

Good afternoon, Chair Sylvia Luke, Vice Chair Scott Nishimoto and members of the House Finance Committee.

I am here to testify **strongly in favor** of S.B. 2384, SD1, HD1.

Mahalo for giving me this opportunity to testify before you. My name is John G. McDermott and I have been the State Long Term Care Ombudsman (SLTCO) since August, 1998. The Office of the Long Term Care Ombudsman is both federally and state mandated and has been part of the Executive Office on Aging since 1975. Our primary responsibility, per the Older Americans Act, is to be an "advocate" for residents of licensed nursing homes, assisted living facilities, adult residential care homes, expanded adult residential care homes, and community care foster family homes. That total population in Hawai'i is now 12,340.

It is now 18 years since I first testified before you in favor of unannounced inspections. 18 years!! Since then there have been numerous accounts of abuse and neglect, even death, in our long term care facilities that have made the front pages of our newspapers and on the television news. This problem will not go away with the current regulations. We would all like to believe such instances are the rare exception (and I actually do believe that) but we will never know for sure what is happening behind closed doors until we have unannounced inspections. If you tell someone when you are coming, you can't really call that an inspection. It's strictly paper compliance, pro forma, an illusion. Hawaii remains the only state where the licensing agency (Department of Health) is required to give notice when they will be coming to a facility for the annual inspection. No other industry receives such preferential treatment in Hawaii. Because of this advance notice, families are told NOT to visit during the inspection (so no opportunity for family members to complain or express their concerns), inappropriate substitutes are nowhere to be found because the caregiver took off the week from her other full-time job to get prepared, residents are coached on what to say, and residents more likely to complain are taken to the mall during the inspection so they too have no opportunity to voice their concerns.

When Linda Lingle was running for Governor she publicly supported unannounced inspections at many open forums. When she won election, she changed her position and went with a compromise – the inspections would continue "with notice" but there would also be an annual unannounced visit. The unannounced visits did find problems – but that information was not available to the public. The other problem was the Governor doubled the workload of the state surveyors but never doubled the staffing. If this bill passes, the unannounced visits will no longer be necessary because we will finally be doing true inspections so the Department of Health will have the staffing to accomplish this goal.

Unannounced inspections are the standard for every industry across the country. Our care homes, foster family homes and assisted living facilities are the only exceptions. Why? Politics! Please eliminate the politics and do what you know is right for our most vulnerable kupuna. Mahalo.

Dear Chair Luke, Vice Chair Nishimoto, and Members of the Committees:

We **oppose SB2384**, which allows the Department of Health (DOH) to conduct unannounced visits for the purpose of relicensing and recertification for the simple reason: **this law is redundant and would not achieve consumer protection or improved care.**

The DOH already conducts unannounced visits. DOH has no limits as to the number of times they conduct unannounced visits or the time of day or night they can show up at our home where we live and demand to enter our home, as they often do. They can come every single night 365 days of the year. We have nothing to hide. We always let them in. We have no

choice, and we don't see a problem with this system. We don't need this bill to ensure consumer protection because they already conduct unannounced visits.

The reason why licensing/certification visits were announced is to ensure efficiency. During a licensing/certification visit, the home is required to produce an incredible amount of paperwork that must often be updated. Only the operator or primary caregiver has access to these documents (mortgage documents, rental agreements, budget, insurance, criminal records clearance, fingerprinting, educational documents, TB clearance, and other financial information). If DOH shows up unannounced in the middle of the night and the primary care caregiver is unavailable, DOH will not be able to access the documents forcing DOH to either return for another visit, issue a corrective action plan, or deny licensure and find new homes for the clients, which is always detrimental to client care – not because the care fell below the standard, but only because documents may have not been available due to DOH's unwillingness to provide notice. Remember, we often hire licensed substitutes (CNAs) from agencies – people to whom one won't entrust sensitive financial documents like mortgage and budget documents - it's like giving these documents to a babysitter or gardener.

This would create a completely unworkable and chaotic system that would require DOH to expend additional resources unnecessarily. Meanwhile, our compensation rates have not been raised for almost 10 years; and now DOH is starting to talk about licensure fees.

The problem stems from the State's lack of understanding of Community Care Foster Family Homes (CCFFHs). We are not facilities. We are not "care homes" or "care home operators" as we are referred to in some committee reports. We are basically families who have accepted our clients as part of our family. We don't have a custodian of records on duty at all times like other facilities. We only have a maximum of 3 clients, not 5, 8, 15 or hundreds. Remember, we are required to keep some of the documents above on everyone who lives in our household whether they provide care or not.

Visit us unannounced anytime to ensure patient care and consumer protection. But if you need us to get our mortgage, rental, budget, fingerprints, and over 50 other documents (no kidding – this is the amount of documentation we are required to keep), you must give us some notice. For these reasons, we **oppose SB2384**.

Aloha Chair Luke and Committee Members:

My name is Ramon Sumibcay. I am a Care Home Operator (Adult Residential Care Homes – ARCHs) in Makakilo. The care home industry comprises of about 500 care homes and about 1100 Family Foster Care Homes – CCFFHs). SB2384 was referred to your Committee for hearing soon. I am hereby declaring my strong OPPOSITION to the bill in particular to the section regarding care homes.

First and foremost, I am respectfully asking your Committee that this section of HRS 321-15.6: <u>"Annual inspections for relicensing shall be conducted with</u> notice, unless otherwise determined by the department." be retained and should not be changed.

For transparency and for the welfare and protection of our Kupuna, the abovementioned HRS already allows the Office of Health Care Assurance (OHCA) to conduct **unannounced visits** at any intervals at its discretion to confirm correction of deficiencies and/or to investigate complaints for suspicion of neglect and abuse.

I would like to draw your attention to these data provided by the DHS Adult Protective and Community Services Branch:

Chair Luke, as you can see from the data, provided by the Department of Human Services, Adult Protective and Community Services Board, cases of abuse and neglect in the ARCHs are very low in numbers. We can do better. The CCFFHs may have to do some work to improve their numbers. I have to say that, although DOH and DHS have merged under one roof in 2014, but the rules governing ARCHs and CCFFHs are still different to include relicensing/recertification visits.

Chair Luke, for the past 25 years there were 2 deaths in the care facilities. The incident in the 1990s happened in an ARCH, and the recent incident happened in CCFFH. But both cases were highly preventable. Honestly, we don't need a legislation to solve the problem. As a Registered Nurse myself, I know decubitus ulcers could be prevented and when treated promptly, ulcers are not life-threatening situation. We just need **INTEGRITY and ACCOUNTABILITY** to all individuals involved with a patient's care.

Annual relicensing survey **WITHOUT NOTICE** does not prevent deaths, abuse or neglect in any care facility. Annual survey for relicensing is primarily for administrative purposes to make sure that the care home is complying with the list of requirements or the care home is in compliance with Chapter 100.1.

DOH's testimony submitted at the Health Committee hearing, the only reason cited was: "To maximize the readiness of the care homes or dispensaries for an inspection by the Department. This will be consistent with all other relicensing inspections of health care facilities under the regulatory responsibility of the OHCA, and is seen as an improved safeguard for the public." I believe, the unannounced visit is more powerful tool OHCA can use at its disposal to protect the welfare of our fragile and aging elderly population.

It is a little difficult to make comparison between care homes and other healthcare facilities. Most case facilities are "mom & pop industry" where the operator has many tasks to do aside from caregiving.

The current practice of the Department of Health through the Office of Health Care Assurance (OHCA) is to send notice to the care home operator regarding an upcoming annual relicensing inspection. The notice says "a certain day of the month but it does not announce the exact date." The reason OHCA has promulgated this system to allow the care home operator to be present during the inspection. There are many reasons that the care home operator could be out the house at any given time; such as bringing residents to their medical appointments, picking up medications, buying provisions and supplies for the residents, outings for residents, and once in a while a trip to the emergency room. In addition, care home operators have also personal appointments and errands. OHCA requires that the primary caregiver, the care home operator, and the residents must be present during the annual relicensing inspection.

I believe the system is working fine and it does not need a piece of legislation just for a minor reason as cited by the Department.

Please retain the language in the statute, "Annual inspections for relicensing <u>shall be</u> <u>conducted with notice</u>, unless otherwise determined by the department."

I am writing to offer strong support for the above bill, which mandates unannounced visits and inspections, including relicensing visits, to a wide range of state-certified or state-licensed facilities for the elderly and developmentally disabled.

Unannounced inspections and visits are particularly critical with regard to these types of facilities, which care for frail and disabled populations. Residents and users of these facilities are especially vulnerable and dependent upon their care providers. If abuse or neglect takes place, family members are often unaware until the situation becomes threatening to life or health.

Owners and operators of some of these facilities have successfully fought unannounced inspections for many years. Among the arguments used is the fact that the owner may not be present when inspectors arrive, and that owners may not have enough time to get their facilities and records in proper order. Regarding the first argument, if owners are absent on the day of the inspection a qualified substitute caregiver must be present. As for the second argument, unannounced inspections will serve as a powerful tool to require that facilities and their books be in order at all times, as they should be.

Finally, on a personal note, my wife spent the last eight months of her life in a care home. This facility and its staff provided excellent care for a small group of patients with extensive needs. I am certain that this care home could have been inspected on any day, and it would pass with flying colors. This is the model to which all such facilities should aspire.

Thank you for the opportunity to testify on this much needed legislation.

Aloha Chair Luke and Committee Members:

My name is OFELLA SIMPLICUANDSB2384 was referred to your Committee for hearing soon. I strongly OPPOSE the bill in particular the section regarding care homes.

Currently, HRS 321-15.6 has this provision: <u>"Annual inspections for relicensing shall be conducted with</u> <u>notice</u>, unless otherwise determined by the department." I hereby respectfully ask the Chair and Members to retain the language. In addition, for transparency and for the welfare and protection of our Kupuna, the above-mentioned HRS already allows the Office of Health Care Assurance (OHCA) to conduct <u>unannounced visits</u> at any intervals at its discretion to confirm correction of deficiencies and/or to investigate complaints for suspicion of neglect and abuse.

According to data and statistics gathered and published by DHS Adult Protective and Community Services Board, in 2014, there were 168 confirmed cases of abuse and neglect from 1,104 reports. Out of those reports, there were 445 relatives as perpetrators (44%), and staff of caring facility was reported at 15% with 152 cases. Furthermore, data showed 13 incidents (1%) happened in ARCHes and 5 (0%) happened in E-ARCHes. Obviously, the numbers do not indicate that we need a legislation to warrant an unannounced relicensing/recertification visits. On the CCFFHs side (family foster homes), the numbers are a little bit higher, but with tighter OVERSIGHT and ACCOUNTABLITY to all individuals involved with the care of an elderly, those numbers should go down.

Annual relicensing survey WITHOUT NOTICE does not prevent abuse or neglect in any care facility. Annual survey for relicensing is primarily for administrative purposes to make sure that the care home is complying with the list of requirements or the care home is in compliance with Chapter 100.1.

According to DOH's testimony submitted at the Health Committee hearing, the only reason cited was: "To maximize the readiness of the care homes or dispensaries for an inspection by the Department. This will be consistent with all other relicensing inspections of health care facilities under the regulatory responsibility of the OHCA, and is seen as an improved safeguard for the public." It is a little difficult to make comparison between care homes and other healthcare facilities. Most care facilities are "Mom & Pop industry" where the operator has many tasks to do aside from caregiving.

The current statute already allows for any number of **unannounced visits** at **any time**, 24 hours a days, 7 days a week, 365 days a year. We **welcome** the Department of Health into our **private homes** at **their will** anytime to maintain our transparency and credibility with the general public. So why does the Department of Health need to do annual relicensing inspections (these inspections are facilitated to check for administrative discrepancies) without notice? **They** claim the purpose of these unannounced visits is to provide for "an improved safeguard for the public".

Also, the current statute includes that Annual Relicensing Inspections would be "**WITH**" notice. I would like to clarify what is meant by, "with notice".

The Department of Health sends the operator a letter approximately one month in advance of the inspection month notifying them of the specific month and the day of the week that they "**may**" show up for their annual relicensing inspection. This ensures that the care home operator is present during the inspection. Not taking residents to their medical appointments, picking up medications or shopping for food for both the residents and or their own families.

I am humbly requesting that your Committee put back the language of the existing HRS 321-15.6 "Annual inspections for relicensing shall be conducted " WITH" notice, unless otherwise determined by the department."

I have served on state and national task forces on elder abuse and neglect, long term care industry best practices, and national policy work groups for long term care. I have been a Certified Medical Director with the American Medical Directors Association (long term care medicine society) and have also worked closely with the State of Maine's Long Term Care Ombudsman program for over 20 years.

I was very surprised and disappointed to find that Hawaii is the ONLY state that requires its licensing agency to "announce" or give warning for any on-site inspections of long term care facilities. Not only is this unwise public policy (as evidenced by the other 49 states allowing this), but also it does a grave disservice to our most frail and vulnerable citizens who live in long term care facilities.

As I understand it, the only serious arguments against allowing unannounced inspections are from the Dept. of Health as it does not have an adequate budget to perform these needed duties, and from the long term care facilities who do want this visibility. Let me ask if you would like a facility that cares for your loved one to be able to "tidy up" and prepare for any visit by an inspector? No, you would like inspectors to see the real situation in every nursing home and care home – because that is what your mother would experience on a day to day basis. Even the long term care physicians groups support unannounced inspections because we all want excellent care for our most vulnerable citizens – each hour of the day, each day of the week, and each week of the month.

Please bring Hawaii's long term care licensing system up to a standard that we can be proud of, and one that will protect our most vulnerable.

My name is Debotra Costvo. I am a Care Home Operator (Adult Residential Care Homes - ARCHes) in SB2384 was referred to your Committee for hearing soon. I strongly OPPOSE the bill in particular the section regarding care homes.

Currently, HRS 321-15.6 has this provision: "Annual inspections for relicensing shall be conducted with notice, unless otherwise determined by the department." I hereby respectfully ask the Chair and Members to retain the language. In addition, for transparency and for the welfare and protection of our Kupuna, the above-mentioned HRS already allows the Office of Health Care Assurance (OHCA) to conduct unannounced visits at any intervals at its discretion to confirm correction of deficiencies and/or to investigate complaints for suspicion of neglect and abuse.

According to data and statistics gathered and published by DHS Adult Protective and Community Services Board, in 2014, there were 168 confirmed cases of abuse and neglect from 1,104 reports. Out of those reports, there were 445 relatives as perpetrators (44%), and staff of caring facility was reported at 15% with 152 cases. Furthermore, data showed 13 incidents (1%) happened in ARCHes and 5 (0 %) happened in E-ARCHes. Obviously, the numbers do not indicate that we need a legislation to warrant an unannounced relicensing/recertification visits. On the CCFFHs side (family foster homes), the numbers are a little bit higher, but with tighter OVERSIGHT and ACCOUNTABLITY to all individuals involved with the care of an elderly, those numbers should go down.

Annual relicensing survey WITHOUT NOTICE does not prevent abuse or neglect in any care facility. Annual survey for relicensing is primarily for administrative purposes to make sure that the care home is complying with the list of requirements or the care home is in compliance with Chapter 100.1.

According to DOH's testimony submitted at the Health Committee hearing, the only reason cited was: "To maximize the readiness of the care homes or dispensaries for an inspection by the Department. This will be consistent with all other relicensing inspections of health care facilities under the regulatory responsibility of the OHCA, and is seen as an Improved safeguard for the public." It is a little difficult to make comparison between care homes and other healthcare facilities. Most care facilities are "Mom & Pop industry" where the operator has many tasks to do aside from caregiving.

The current practice for the annual relicensing visit is OHCA sends notice to the care home operator regarding an upcoming annual relicensing inspection. The notice says "a certain day of the month but it does not announce the exact date." The reason OHCA has promulgated this system to allow the care home operator to be present during the inspection. There are many reasons that the care home operator could be out the house at any given time; such as bringing residents to their medical appointments, picking up medications, buying provisions and supplies for the residents, outings for residents, and once in a while a trip to the emergency room. In addition, care home operators have also personal appointments and errands. OHCA requires that the primary caregiver, the care home operator, and the residents must be present during the annual relicensing inspection.

I believe the current system is working wall, and the care home industry does not need another piece of legislation to justify the reason cited by the Department for an unannounced relicensing visit.

Please retain the language in the statute, "Annual inspections for relicensing shall be conducted with notice, unless otherwise determined by the department."

Aloha Chair Sylvia Luke, Vice Chair Scott Y. Nishimoto, and Finance Committee Members,

My name is Elena A. Galario, and I am a Care Home Operator in Waipahu, Hawaii. I am in strong opposition to the bill, SB 2384, in particular to the section regarding care homes.

Currently, community-based care facilities are governed by different regulations regarding unannounced visits and annual inspection for relicensing. The Department of Health (DOH) has jurisdiction over the Adult Residential Care Homes (ARCH) under the guidance of Hawaii Revised Statutes (HRS) Section 321-15.6. The Department of Human Services (DHS) has the jurisdiction over the foster family homes using the guidelines under Hawaii Administrative Rules Title 17, Chapter 1454. I am respectfully asking the Committee to retain the language of HRS § 321-15.6: "Annual inspections for relicensing shall be conducted with notice, unless otherwise determined by the department."

The DOH supports SB 2384, in it current form. The DOH in its testimony submitted at the Health Committee hearing, cited the following reason why it supported the bill, "To maximize the readiness of the care home or dispensaries for an inspection by the Department. This will be consistent with all other relicensing inspections of health care facilities under the regulatory responsibility of the OHCA, and is seen as an improved safeguard for the public." It is difficult to make the comparison between care homes and other health care facilities. Most care home facilities are of the "mom and pop industries", are small businesses, and provide services to 1-6 residents, whereas health care facilities are "bigger" businesses, have many employees, and provide services to many clients.

The current practice of the DOH, through the Office of Health Care Assurance (OHCA), is to send a notice to the care home operator regarding an upcoming annual relicensing inspection. For example, the notice may state, "Your annual inspection will take place on a Tuesday in the month of June 2016." The reason OHCA has utilized this system is to allow the care home operator to be present during the inspection. OHCA requires that the primary caregiver, the care home operator, and the residents be present during the annual relicensing inspection. There are many reasons why a care home operator may not be home on any given day, such as bringing the residents to their medical/dental appointments, picking up resident's medications, buying provisions and supplies for the residents, planned outings for residents, and the rare trip to either an urgent care facility or the emergency room. In addition, the care home operators may not be present at the home due to their own personal appointments (medical or otherwise), errands, and in-services/continuing education classes.

The statute already has a provision for unannounced visits. OHCA can conduct announced visits at any intervals at its discretion to confirm correction of deficiencies and/or complaints for suspicion of neglect or abuse.

According to the data and statistics gathered and published by DHS Adult Protective and Community Services Board, in 2014, there were 1,104 reported cases of suspected abuse and/or neglect. Out of the 1,104 reported cases, there were 168 confirmed cases of abuse and/or neglect. Out of those reported cases, the perpetrators were listed as follows: 445 cases involved relatives (40.3%), and 152 cases involved care facilities staff members (13.7%). Furthermore, the data showed that of the reported suspected cases of abuse and/or neglect, 13 cases (1.1%) happened in ARCH facilities and 5 cases (0.4%) occurred in Expanded ARCH facilities. The statistics do not indicate that we need legislation to warrant an unannounced licensing/recertification visits. Annual relicensing without notice does not prevent abuse or neglect in any care facility. Annual survey for relicensing is primarily for administrative purposes to make sure that the care home is complying with the list of requirements or the care home is in compliance with Hawaii State Department of Health Chapter 100.1.

I believe that the current annual relicensing system is working well, and the care home industry does not need another piece of legislation to abide by, based upon the Department's provided reason for an unannounced relicensing visit.

Please retain the language in the HRS § 321-15.6, "Annual inspections for relicensing shall be conducted with notice, unless otherwise determined by the department."

On the CCFFHs side (family fester homes), the numbers are a little bit higher, but with tighter OVERSIGHT and ACCOUNTABLITY to all individuals involved with the care of an elderly, these numbers should go down.

Annual relicensing survey WITHOUT NOTICE does not prevent abuse or neglect in any care facility. Annual survey for relicensing is primerily for administrative purposes to make sure that the care nome is complying with the list of requirements or the care home is in compliance with Chapter 100.1.

According to DOH's tostimony submitted at the Health Committee hearing, the only reason cited was: "To maximize the readiness of the care homes or dispensaries for an inspection by the Department. This will be consistent with all other relicensing inspections of health care facilities under the regulatory responsibility of the OHCA, and is seen up an improved safeguard for the public," It is a little difficult to make comparison between care homes and other healthcare facilities. Most care facilities are "Mom & Pop industry" where the operator has many tasks to do aside from caregiving.

The current practice for the annual relicensing visit is CHCA sends notice to the care home operator regarding an upcoming annual relicensing inspection. The notice says "a certain day of the month but it does not announce the exact date." The remeon OHCA has promulgeted this system to allow the care frome operator to be present during the inspection. There are many reasons that the care home operator could be out the house at any given time; such as bringing residents to their medical appointments, picking up medications, buying provisions and supplies for the residents, outings for residents, and once in a while a trip to the emargency room. In addition, care home operators have also personal appointments and emands. OHCA requires that the primary caregiver, the care home operator, and the residents must be present during the annual relicensing inspection.

Re: SB 2384 S.D. 1 Relating to Licensing Inspections

My name is Myriam Tabaniag, a Registered Nurse, owner and manager of 2 home-based Long Term facilities in Kaneohe, a Type I, 5-bed care home and a Type II, 8-bed care home, for 15 years now.

I understand the intent of SB 2384 S.D. 1 BUT I <u>STRONGLY OPPOSED TO</u> THE SECTION OF THE BILL RELATING TO THE UNANNOUNCED ANNUAL RELICENSING OR RECERTIFICATION OF STATE- LICENSED CARE FACILITIES, such as Adult Residential Care Homes; Expanded Adult Residential Care Homes, CCFFH homes, etc.

Section 321-15.6 of the Hawaii Revised Statutes states "The Department shall conduct unannounced visits, other than the inspection for licensing, to every licensed adult residential care home and expanded adult residential care home on an annual basis and at such intervals as determined by the department to ensure the health, safety, and welfare of each resident. Unannounced visits may be conducted during or outside regular business hours.... Annual inspections for relicensing shall be conducted with notice, unless otherwise determined by the department.

At the present time, both Adult Residential Care Homes and Expanded Adult Residential Care homes are already subjected with 1 or more unannounced visits per year at anytime. More if the Department found something during the unannounced visit that would warrant the consultant to revisit the care home, such as in cases of abuse and neglect, etc.

The Annual Inspection for relicensing is partly unannounced. The day and month are given but not the date. The notice usually read, "Any Tuesday in the month of May." Occasionally, there may be 5 Tuesdays in the month, so the Primary Care Giver will persevere to wait for that day, as no Primary Caregiver (PCG) would know which Tuesday of the month the Consultant would come. The survey entails reviews of the chart's Progress Notes, Medication Records, Nutrition (Intake and Output) Records, Monthly Weights, Doctor's visits, Incident Reports, Fire Drill Records, Fire Alarms Maintenance Records, Sprinkler System records, Refrigerator Temp. Log records, Menu Substitution Records, and many, many more. Most times, the Consultant will ask questions about the records, the plan of care and please remember that if the Case Manager, who is a part of the Team did not complete his or her job or work, it is the Primary Caregiver of the Home that will get the deficiencies. I've been told by many caregivers that the DOH Consultant may visit them a different day than what was written on the notice, or sometimes, the Consultants are also very busy doing unannounced visits when they are called to check possible cases of abuse and neglect, that they may not be able to come that month. There's always a possibility that the Consultant may come when the PCG is out with a resident who was taken to the ER for an emergency on inspection day. My practice is, I will not leave my resident while in the ER being treated. It takes about 6 hours to complete a Survey in a 5-bed care home, 2 days for an 8-bed care home. With the partly unannounced annual inspections, almost all care home facilities still have a minimum of 2-8 pages of listed deficiencies.

Page 2:

Relicensing inspection and survey will not ensure nor ascertain the physical, mental and emotional health, and welfare of the individual residents. The huge and beautiful building and the well decorated interior of the facility are just a plus. What really counts and most important, and what the resident is actually paying for when he or she enters a facility is the quality of life and the quality of care that he or she receives.

What's the sense of having a beautiful and well-decorated home; completed records because that's all what the PCG did the whole time to get a good survey but neglected to give or gone the extra mile to render the quality of care and the quality of life that the resident needed. I truly believe that the 6 hours to 2 days of unannounced annual inspection will NOT cut it as it won't show the many unrecorded activities, outings, restaurant visits, trips that we did for and with them that truly made them smile, laugh and contented with their lives.

I also believe in my heart that the care home industry is over regulated.

Unannounced Annual Relicensing or Recertification Inspections when the Primary Caregivers and owner of the care home facilities are not present in the home when being inspected by DOH Consultants may be infringing in the civil rights of the Residents as well as the Primary Caregivers especially if permission was not granted to enter the property. Annual Inspection include but not limited to the physical inspection of the whole house that may occasionally include the private bedrooms of the primary caregiver. It could also be **discriminatory**. Our personal choices are protected by the freedoms to express himself or herself and the **right to preserve personal privacy**.
