- Children are a vulnerable population that need guidance, advocates, and support. Increasing access to information and help regarding cases of abuse or neglect could give these vulnerable children a voice.
- Children are not the only individuals who would utilize the information and help hotlines. Many parents, teachers, or faculty members might not be aware of the proper ways to report child abuse. Visibility and access of information could potentially increase the number of reports made by adults as well. As a Social Worker, I believe that it is critical to provide equal community access to resources and information. Every individual and child deserves a chance to be heard.
