### In consideration of SB2483 SD1 RELATING TO FIREWORKS.

Chair Baker, Vice Chair Kidani, and Members of the Senate Committee on Commerce, Consumer Protection, and Health.

The Department of Business, Economic Development and Tourism (DBEDT) supports SB2483 SD1, which would provide additional requirements for shippers and an exception in Chapter 132D-6 for movie and television productions to use pyrotechnics in specific ways when filming a scene with a valid permit issued by a county fire department. With regard to safety of the public DBEDT defers to the City and County Fire Department.

In 2015, an estimated \$244 million in production expenditures were generated in film and television in Hawaii providing over \$427 million in estimated economic impact for Hawaii. The film industry often utilizes pyrotechnics as part of special effects and stunts. The Legendary Pictures feature *Kong: Skull Island* was filmed in Hawaii from October to December 2015, and extensively used pyrotechnics. The ongoing TV Series, *Hawaii Five-O*, often uses pyrotechnics – creating an exciting array of action-packed story telling. These and other productions use only licensed pyrotechnic professionals to execute these operations precisely and carefully on set. The requested exemption will ensure that
