In consideration of SENATE BILL 2579 RELATING TO FISHING ON THE NORTH COAST OF MOLOKA'I

Senate Bill 2579 proposes to designate certain state waters surrounding the north coast from Kalaupapa to Halawa on the island of Moloka'i as the Moloka'i Community-Based Subsistence Fishing Area. While the Department of Land and Natural Resources (Department) supports the concept of community based co-management, we oppose this measure.

The Legislature authorized the department to establish community based subsistence fishing areas in 1994 under Section 188-22.6, Hawaii Revised Statutes. We have been working with the Molokai community at Mo'omomi and continue to work with this community on this issue. While the bill is addressing a different area, we are developing a process that all communities can follow. We ask this committee to allow the Department to continue its community process pursuant to the intents and authorities the legislature has already provided us.

We believe this measure is unnecessary as we are already in discussions with a number of communities on subsistence fishing areas (SFA), we already have the statutory authority to create these SFA's, and we have developed a guidebook that details the process to establish them. We understand that some in the community are dismayed with the slow pace of progress, but the Department has to be deliberative in its process to ensure that all public interests are considered.

Lastly, we are concerned that the measure proposes types of regulations that are still yet to be discussed in the community. The prescriptive language in this measure may result in regulations being made that the community does not understand or support.

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS WITH AMENDMENTS</u> SB2579, which seeks to better empower kīpuka communities in North Moloka'i, to guide the management of the nearshore resources that inform their cultural traditions, values, and way of life.

Community-based fisheries management can help sustain Hawai'i's nearshore resources, and perpetuate the cultural lifestyles and values that depend upon them. OHA appreciates the intent of this measure, in demonstrating the Legislature's continued support of community-based fisheries management, particularly for the subsistence-dependent island of Moloka^ci.

Community-based fisheries management has long been cited as a key component in sustainably managing our ocean resources, which are currently open to exploitation by the general public, and are typically subject to generic regulations of questionable sufficiency.¹ This management approach relies in part upon subsistence, "kīpuka" communities' intimate knowledge of and concern for the nearshore resources in their area, to guide the establishment of sustainable, place-specific harvesting practices. In recognition of the potential for community-based management to address the continuing decline of our nearshore resources, while also perpetuating Hawai'i's cultural traditions and values, the Legislature authorized the Department of Land and Natural Resources to work with traditional subsistence communities in establishing "community based subsistence fishing areas" (CBSFAs) and rules over 20 years ago.

However, notwithstanding the long-standing authority given to the Department, as well as the diligent efforts of subsistence communities in many areas of the state, rules have now been established for only a single CBSFA, on the island of Kaua'i.

This measure may provide the legislative encouragement needed for the adoption of a community-based management approach for Moloka'i's north shore fisheries. With the looming impacts of climate change, population growth, and the mounting pressures on our limited nearshore resources, the need to more proactively explore community-based fisheries management throughout our islands is greater now than ever before. For the island of Moloka'i, where subsistence fishing, hunting, and gathering provide for a substantial

proportion residents' daily diets, this need may be particularly acute. Fortunately, the deep traditional knowledge and values still possessed by some Moloka'i residents regarding their nearshore resources may greatly increase the chances of success for a CBSFA approach. The rulemaking actions required under this measure may therefore be critical to maintaining and perpetuating the health of Moloka'i's nearshore resources, as well as the subsistence communities, traditional lifestyles, and cultural values that depend on them.

OHA notes that this measure should be amended to more properly reflect the role of administrative "rules," which generally describe prohibited and permitted conduct, and that of a "management plan," which contains additional components including internal agency matters and planning provisions that do not affect the rights of the public. Insofar as a management plan encompasses such non-regulatory matters, it is not appropriate for promulgation as a "rule" subject to the chapter 91 rulemaking process, as suggested by subsection (c). In addition, OHA recommends providing express rulemaking authority regarding non-fishing activities, such as thrill craft riding in sensitive areas, which may nevertheless directly impact traditional and customary practices or subsistence resources. Accordingly, OHA urges the Committee to amend subsection (c) beginning on page 4, line 12, to read as follows:

(d) The department of land and natural resources, as soon as practicable, shall consult with as broad a base as possible, group of inhabitants of the island of Moloka'i and other interested parties to establish rules for the Moloka'i community-based subsistence fishing area, to include but not be limited to:

- (1) Limits on the harvest of aquatic life, as those terms are defined in section 187A-1, in the fishing area;
- (2) Limits on other activities that may disturb, degrade, or alter the marine environment, or that may directly interfere with harvesting or gathering practices or subsistence resources, including but not limited to boating and other non-extractive activities; and
- (3) The establishment of no harvesting, no fishing, or

appropriate.

Therefore, OHA urges the Committee to **PASS WITH AMENDMENTS** SB2579. Mahalo nui for the opportunity to testify on this measure.
