### In consideration of SENATE BILL 263 RELATING TO KE'EHI LAGOON BEACH PARK

Senate Bill 263 proposes to make an appropriation for the replenishment of the man-made beach at Ke'ehi Lagoon Beach Park, which is managed by the City and County of Honolulu. The beach park is heavily utilized for canoe racing and boating. **The Department of Land and Natural Resources (Department) supports this bill provided that its passage does not replace or adversely impact priorities indicated in the Executive Biennium Budget request.** 

As you know, part of the Department's mission is to manage coastal areas and ocean resources through the Department's Office of Conservation and Coastal Lands (OCCL). OCCL works closely with the City and County of Honolulu Parks Department (City Parks) on beach management efforts for shoreline areas under shared jurisdiction, including recent projects at Kailua, Makaha, and Pupukea-Sunset Beach Parks. A collaborative project between City Parks and OCCL should be implemented to restore the beach at popular and heavily used Ke'ehi Lagoon Beach Park, provided any appropriations from this bill do not impact priorities in the Executive Biennium Budget request.

It is a practice site and is frequently used by canoe associations HCRA, OHCRA, Hui Wa'a, and NOCRA as a place to hold regattas and races.

My Name is Samantha Mokuahi Moikeha. I presently serve as the President of Na Ohana o Na Hui Wa'a, one of the outrigger canoe racing associations on the island of Oahu. I am also the Race Secretary for the Hawaiian Canoe Racing Association (HCRA), our state wide Canoe Racing Association. We support SB263 to replenish the beach at Ke'ehi Lagoon Beach Park.

With five of our clubs based out of Keehi Lagoon, this project is very important to us as we utilize Ke'ehi Lagoon for training and competition on a year-round basis. The rapid decrease in sand on the shoreline has made it difficult on paddlers as well as equipment.

Having the beach at Keehi Lagoon replenished will ensure that our paddlers will have a safer area to train and compete. Keehi Lagoon is used on a year-round basis by many associations including the high schools and outer island associations. Na Ohana O Na Hui Waa has about 400 paddlers during our summer season that use Keehi Lagoon on a daily basis. Our regattas at this location serve close to 1600 paddlers and when the HCRA state race is held on Oahu, Keehi Lagoon accommodates close to 8000 paddlers and participants. All paddlers and citizens state wide would benefit from this project.

# SB 263 - RELATING TO KE'EHI LAGOON BEACH PARK. Makes an appropriation for the replenishment of the beach at Ke'ehi lagoon beach park.

To Whom It May Concern,

My name is Clinton Schultz and I am the Athletic Director at Anuenue School as well as the Oahu Interscholastic Association's (OIA) Sport Director for Outrigger Canoe Paddling. I am also affiliated with the Na Opio Canoe Racing Association (NOCRA) and the Oahu Hawaiian Canoe Racing Association - Hawaii (OHCRA Hawaii) in the capacity of Vice President and Race Coordinator. I am in support of Senate Bill 263 as it relates to the replenishment of the sand which relates directly also to the safety concerns for Ke'ehi Lagoon Beach Park. I assist and support these canoe paddling associations and have contact with the Keehi Lagoon Beach Park on an almost daily to weekly basis. This location serves as a wonderful venue for our paddling activities to take place.

Keehi Lagoon Beach Park is a wonderful venue for many activities, but as far as Outirgger Paddling is concerned, it is more than a beach...it is a home and gathering center for all of us. Currently there are seven (7) clubs that use the beach on a yearly basis and numerous clubs and schools that utilize the beach park between October and March. The average number of studentathletes and other level of paddlers using the beach park can be over 400 people on the very best days. Due to the amount of people using the beach park daily, this bill would provide much needed support for all of them. There are also approximately 40 organized events that are supported by the paddling community every year. The age range of our paddlers range from six years old to over 80 years old. The Keehi Lagoon Beach Park and Lagoon are used consistently all year long and serves as a prime venue to perpetuate our Hawaiian Culture and Heritage through outrigger canoe paddling.

At low tide, what is left of the beach is exposed and poses safety concerns for all participants, athletes, support staff and coaches, included. At other times, rocks and eroded shoreline still pose threats to anyone in the area as well as the normal park users. Where there was once beach has given way to sharp rocks and dangerous shore erosion areas throughout the shoreline. We have had many people that have been treated for cuts, both minor and major, as well as numerous abrasions. Hence, by replenishing the sand and beach to the Keehi Beach Park, this would create a much safer environment and better peace of mind for all to enjoy.

Also the bathroom need to be better up kept due to the abundance of homeless the restroom get worn down quicker.
