As apex predators these species keep fisheries healthy, maintaining a healthy balance of individuals and species. They also protect other species from overconsumption by other predators. Rays also play a key role in our coastal ecosystems. With human impacts on coastal ecosystems increasing worldwide, these species are threatened by habitat destruction. Thus we should aim to protect those populations that reside here in Hawaii. Many other islands have limited or stopped shark fishing in their waters, including Palau and French Polynesia, and have benefited in increased fishery viability.

Above the ecological responsibilities we have to maintain our fisheries, is our responsibility to stop cruelty towards intelligent life. The more we learn about the cognitive abilities of these creatures, the more similarities between ourselves and them arise. We limit human cruelty to pets because we identify with them, however, it is likely that these species are even more intelligent and social than the pets we protect from this kind of harm. Ban shark fishing! Sharks are an important part of our oceanic ecosystem. They are a keystone species because they are an apex predator. If you are unfamiliar with what this is, let me educate you: a keystone species is a species that keeps all other trophic systems below it in check. This is a kind of checks and balances, like our government. If you remove sharks from the ecosystem, you see an influx in their natural prey (i.e. what they eat) we will call this prey species 1. Prey species 1 population will increase out of control because they will have no more natural predators, and so they will demolish their prey species in turn, and we shall call that prey species 2. With prey species 2 gone, prey species 1 will have to adapt and find a new food source, or will starve and die out. Then you have prey species 3 which was prey species 2 natural prey. That species is going to increase uncontrollably and then wipe out whatever their natural prey is, and then in turn starve and die out. It is a snoball effect. Do you get the big picture now?
