## RELATING TO THE EMPLOYER-UNION HEALTH BENEFITS TRUST FUND

Chairs Keith-Agaran and Baker, Vice Chair Shimabukuro and Kidani, and Members of the Committees:

The Hawaii Employer-Union Health Benefits Trust Fund (EUTF) Board of Trustees has not had an opportunity to take a position on this bill. However, the Committee should be aware that currently the EUTF has added all of the benefits mandated by this bill to the EUTF active employee and retiree medical plans, excluding the HSTA VB plans offered by the EUTF. Only the autism and orthodontic services for orofacial anomalies benefits has not been added to the HSTA VB active employee and retiree plans as mandated by this bill. The HSTA VB active employee and retiree plans were created in accordance with Kono, et al v. Abercrombie lawsuit for the members in the Hawaii State Teachers Association Voluntary Employees' Beneficiary Association Trust (HSTA VEBA) as they transitioned from the HSTA VEBA to the EUTF. On January 1, 2011, the HSTA VEBA members, who voluntarily elected to, were moved to the HSTA VB plans created by the EUTF. Generally, the EUTF has maintained the same level of benefits for the HSTA VB plans unless mandated by law. The addition of the autism and orthodontic services for orofacial anomalies benefits to the HSTA VB active employee and retiree plans would cost the active employees, employers and retirees over \$325,000 annually.
