My name is Leimomi Devenport and I am a Master's student from the Myron B. Thompson School of Social Work at the University of Manoa. I will be graduating this May, and am looking at job opportunities outside of Oahu to work with some of our underserved populations on the outer islands.

One of the struggles that I will face if this bill does not pass is that I may have difficulty finding someone to provide supervision for me as I work towards getting my clinical license. It is crucial for practitioners to receive proper supervision to ensure that clients are properly served. The current face-to-face requirement for supervision makes it challenging, if not impossible, to receive supervision for those who practice in rural areas, which are some of the areas most needing social work services.

It is also important that practitioners are encouraged to obtain higher education and their clinical licenses. Just as reducing barriers to services help people get connected to the services and information they need, reducing barriers to obtaining supervision will help increase social work practitioners' ability to obtain clinical licensure. Better access to supervision, allows for increased practitioners obtaining licensure. This betters the social work profession here in Hawaii, and allows us to remain competitive with our mainland counterparts.

I am in support of SB2669 and request that you also support the passing of this measure.

Introduction: My name is Lisa Chilson-McCraw. I am currently a junior at the Myron B. Thompson School of Social Work, University of Hawai'i at Mānoa. Today I will testify on behalf of measure S.B. NO. 2669. I am in support of this measure that will clarify the supervision requirements for licensure of clinical social workers, which would include permitting the supervision requirements to be met via a Health Insurance Portability and Accountability Act-certified video conferencing service.

Becoming a licensed clinical social worker (LCSW) is my dream and long term professional goal. Because the state of Hawai'i is considered rural it is often difficult to find face-to-face supervision, particularly for those working on some of our less populated islands. These neighbor islands are where I plan to practice as a LCSW and areas of which many in my cohort plan to return back to after completing their studies. The passing of this Bill is not only important on a personal level but it will also contribute to the advancement of the social work profession, which ultimately benefits the people of Hawai'i, by helping the marginalized and vulnerable in our society on the micro, mezzo, and macro levels.

Closing: Permitting the use of video conferencing to meet licensure requirements would enable our profession to utilize the advances in technology that are widely used by many other professions today. Senate Bill 2669 is a necessary step in the right direction.

Comments: Greetings: I support HB2669, regarding supervision for social workers in Hawaii. The need for supervision by mental health practitioners seeking licensure who also live in rural areas or on the neighbor islands has created unnecessary hardship on those who seek to advance their knowledge, experience, and credentials in the field of social work. I would also like to advocate that special exception be provided on SECTION 2, (3) (c), line 5 for social workers who are Veterans, Service Members, and their Family (SMVF) members who often struggle to meet the supervision restrictions tied to accumulating sufficient supervision hours "within no more than five years". This limitation presents undue hardship to SMVF whose first priority may be serving our country, as dependents supporting a loved one who experiences multiple changes in duty assignment, or who may require special consideration related to their status as a Veteran. I recommend current language be retained, but with addition language similar (or simplified) indicating the following caveat, "exception being provided to Veterans, Service Members, and their family members who may request extension to the limit of five years, with written statement detailing the reason for the request for extension and verified by written statement from the applicant's current supervisor."
