## **TESTIMONY IN OPPOSITION to SB2692**

### **Description:**

Imposes an excise tax equal to eighty per cent of the wholesale price of any tobacco product, other than large cigars, sold by a wholesaler or dealer on and after January 1, 2017, whether or not sold at wholesale, or if not sold then at the same rate upon the use by the wholesaler or dealer. Requires the additional moneys collected under the excise tax to be deposited to the credit of the Hawaii cancer research special fund.

Committee Members,

The language in **SB2692** is so poorly written, it is unintelligible. Please kill this bill and stop falling prey to unceasing demands of the Hawaii cancer research organization for more money *from victims*.

What can be gleaned from this bill is that it's **predatory**. Very similar to predatory loaning and predatory interest rates. It causes financial hardship on people that are essentially victims and this legislature, in all its fanfare with Quit-Smoking billboards, smoking cessation funds, etc. has done very little to genuinely assist people that want to quit smoking: merely perfunctory to justify accepting the hikes. You do realize the exorbitant cost of cigarettes created an adverse effect on smokers: higher anxiety and a powerful need to smoke more to counteract the anxiety. But I suppose that's a plus for your revenue drive. It has been discovered that those billboards are actually subliminally designed to encourage smoking. It is also a fact that the Quit-Smoking revenues from taxes have been repeatedly diverted to other uses, none of which are to help smokers.

Campaigners for higher cigarette taxes are vociferous in light of rampant indisputable death and destruction that occurs from alcohol use and seemingly have not protested with the same fervor as that of anti-smokers. I really have to ask why that is. Let us be clear, these tax hikes are singling out smokers under thinly disguised reasons of health benefits and smoking cessation but the bottom line is gouging smokers for collecting

revenue. You, personally, may detest smoking (because it's stinky?) but I, personally, detest alcohol consumption and fear its consequences. Do you fear consequences from smokers that might cross into your highway lane because they've had too many cigarettes? No, you don't.

These continuos tax hikes are personal attacks targeting a class of people that are victims of the predatory organizations and legislatures trying to make up for shortfalls seeking their cuts of the tax hikes; and that's not even including the tobacco industry. Because you consume alcohol and wouldn't think of raising tax on alcohol 'products', how discriminatory and predatory is it that tobacco, under a so-called sin tax such as alcohol is also, is exploited more? I didn't find one single bill to raise tax on alcohol!

A **regressive tax** is a tax imposed in such a manner that the decreases as the amount subject to taxation increases. "Regressive" describes a distribution effect on income or expenditure, referring to the way the rate progresses from high to low, so that the average tax rate exceeds the marginal tax rate. In terms of individual income and wealth, a regressive tax imposes a greater burden (relative to resources) on the poor than on the rich: there is an inverse relationship between the tax rate and the taxpayer's ability to pay, as measured by assets, consumption, or income. These taxes tend to reduce the tax burden of the people with a higher ability to pay, as they shift the relative burden increasingly to those with a lower ability to pay. if the activity being taxed is more likely to be carried out by the poor and less likely to be carried out by the rich, the tax may be considered regressive.

I do not see the numbers to back up the claims you have made in this bill as to the increasing impact on health care services nor the evidence for your claim that higher tax reduces smoking.

Taking into consideration all other taxes on tobacco, the picture is even more predatory:

The 156 percent increase in the federal excise tax on cigarettes -- approved last week by the Senate Finance Committee -- is being billed by some as a 'win-win' situation, said the parent company of R.J. Reynolds Tobacco.

But here's what's wrong with it, Reynolds American Inc. said:

First, most of the people who will pay the higher cigarette tax earn less than the people who will get free government health care.

According to Reynolds American, the median household income of an American smoker is about \$35,000. Yet under current congressional proposals, families making up to \$82,000 could become eligible for the State Children's Health Insurance Program.

"Why should lower-income people pay for free insurance for middle- or upper-middleclass earners?" Reynolds American asked in a news release. Load falls on poor to reduce taxes for richest. According to a survey by researchers at RTI International, higher cigarette taxes may be financially hurting low-income smokers rather than making them more likely to quit.

The survey, which looked at more than 13,000 people living in New York state, found that lower-income smokers in the state spent nearly a quarter of their household income on cigarettes compared with an average 2 percent spent by wealthier New York smokers. But even with the higher taxes, the state has not seen a decline in lower-income smokers over the last decade, according to RTI, a non-profit research group that received funding from the New York State Department of Health for the survey.

"Excise taxes are effective in changing smokers' behavior," Matthew Farrelly, chief scientist and senior director of RTI's public health policy research program, and study author, said in a statement. "But not all smokers are able to quit, and low-income smokers are disproportionately burdened by these taxes."

Let's at least be honest in legislative language; higher taxing on tobacco is not to discourage smoking and it is a direct hit on lower income people that may end up choosing between rent and cigarettes. It causes financial hardship on the wrong class of people: the true victims.

Please KILL this BILL and find more creative ways to seek revenues instead of preying on smokers.
