I am Todd Nacapuy, Chief Information Officer (CIO) of the State of Hawai'i, testifying in **strong support** of S.B. **DEPARTMENT'S POSITION**: The Department of Human Services (DHS) supports this administration request.

**PURPOSE**: The measure consolidates the Office of Information Management and Technology (OIMT) and the Information and Communication Services Division (ICSD) of the Department of Accounting and General Services, including all related information technology functions, in the Office of Enterprise Technology Services (ETS) under the direction of the Chief Information Officer.

The consolidation and reorganization of OIMT and ICSD into the Enterprise Technology Services will facilitate the coordination of statewide modernization efforts of information processing and telecommunications services for the state and result in better implementation of specific enterprise services.

The Patient Protection and Affordable Care Act of 2010 (ACA) was the impetus for the Department of Human Services (DHS) to modernize its legacy systems—that were more than 25 years old—commencing with the development of the Medicaid electronic eligibility application system known as KOLEA. The successful build of the KOLEA application was the first major step in the design and development of the DHS Enterprise System that will transform the Department's programs, increase access to and streamline services, improve timeliness in delivery, and improve efficiencies.

The Department of Human Services serves nearly one in four residents of the State of Hawai'i and has the largest operating budget of any state department (about \$3.1 billion), which comprises 73% of the State's federal operating funds. The Department also has the fifth largest staff of any department, with over 2,000 employees staffing its four divisions and three administratively attached agencies in 88 offices throughout the state. The Department is transforming its business processing practices to a whole-family, multi-generational approach, 'Ohana Nui, that ties together health, education, early childhood development, and supporting self-sufficiency of Hawaii's families.

Having information technology expertise within the state's own Enterprise Technology Services will assist in improved efficiency and effectiveness as the Department continues to invest in information technology for the state and Hawai'i residents. Upgraded modern systems will improve our staff's ability to process recipients' applications and requests, improve recipients' access to benefits, services, and their own information, improve program compliance, oversight, and security functions, and support staff morale with improved technology comparable to private sector systems.
