RE: SENATE BILL 2948 RELATING TO SHIP REPAIR

Chairs Inouye and Wakai, Vice Chairs Gabbard and Slom, and Members of the Committees:

The Chamber of Commerce Hawaii ("The Chamber") **supports** SB 2948, which establishes the ship repair industry grant program.

The Chamber is Hawaii's leading statewide business advocacy organization, representing about 1,000 businesses. Approximately 80% of our members are small businesses with less than 20 employees. As the "Voice of Business" in Hawaii, the organization works on behalf of members and the entire business community to improve the state's economic climate and to foster positive action on issues of common concern.

Hawaii's ship repair companies already suffers a geographical disadvantage compared to its mainland counterparts, and can be overlooked completely if the industry cannot provide the level of customer service that is expected elsewhere. Today's vessel owners are more technologically inclined as they provide computer-aided designs of equipment or parts that they need repaired or fabricated. Hawaii's shipyards needs to keep up with the machinery and equipment used in the industry, which is more precise and relies on trained staff. SB 2948 would provide necessary support to bring the industry to a competitive level by replacing old equipment and training qualified staff.

Comments: As an island state, Hawaii faces many unique micro and macroeconomic challenges not found in mainland economies. Hawaii's industrial base, labor markets, and intellectual expertise are critical to the State's economic health and growth. Mainland states can compete for labor and expertise and enjoy a significant cross border transfer of skills among industries. But due to the high cost of living and remoteness, Hawaii does not enjoy the same cross border transfer of industrial skills. The trend has been that once an industrial skill leaves, it is lost to the State. If a local industry or labor skill is lost to off-island interest, the ability to replace the industry or capability is difficult at best. Since the early 1990's, the ship repair industry in Hawaii has diversified into critical industrial sectors that insures Hawaii's ship repair industrial base remains robust and viable. It employs over 750 HIGHLY SKILLED TRADE EMPLOYEES and their related support team personnel and TOTAL INDUSTRY REVENUE EXCEEDS \$100M. Vessels repaired include cargo ships delivering goods to the islands, interisland barges for cargo and fuel, workboats including Tugs, Pilot boats, and other specialty boats, USCG ships and boats, US Navy ships and boats, US Army landing craft, State and C&C security patrol and first responder boats, commercial fishing boats and passenger boats. Due to our geographic isolation and high cost of labor and materials costs, the ship repair industry must REMAIN COMPETITIVE. It must also provide the level of customer service that is expected or the norm elsewhere. Today's vessel owners are increasingly providing computer aided design drawings of things that they need repaired or fabricated. Machinery and equipment used in ship repair are now faster, more precise and increasingly relies upon computer technology. THE SHIP REPAIR INDUSTRY IS AN IMPORTANT INDUSTRY WITH A CLEAR NEXUS TO HAWAII. HAWAII'S SHIPYARDS NEED TO PROVIDE THEIR WORKERS WITH THE RIGHT TOOLS AND TRAINING TO REMAIN COMPETITIVE - AND RETAIN THESE HIGH SKILLED JOBS AND REVENUE IN HAWAII.

A grant program will make a difference in our ability to improve the skills of our workforce and to provide them with better tools and equipment that will ultimately deliver a higher quality product to the vessel owner. Vessel owners can compare the quality and cost of a job between Hawaii and mainland shipyards but by delivering a high quality product and within the owner's time frame, the customer will be more satisfied and more likely to retain the work in Hawaii. A grant program will help to reduce the cost of training our employees who have to obtain and maintain certain annual certifications to work on Navy vessels and it will help us purchase new machinery and equipment which are more accurate and faster and which might not be economically feasible if external financial support isn't available. Retaining work on vessels at Hawaii shipyards benefits other local companies that supports the shipyard in the areas of environmental and waste disposal, equipment rental, material suppliers, trucking, marine chemists, inspectors, labor agencies, and other industry trade workers such as electrical, plumbing and air conditioning.

Your support of SB2948 will be greatly appreciated by all of these companies that rely upon the shipyards to keep the work in Hawaii.
