On behalf of the Hawaii Health Systems Corporation ("HHSC") Corporate Board of Directors, thank you for the opportunity to present testimony in strong support of SB305, SD1, HD1, that prohibits tobacco and electronic smoking device usage on HHSC campuses state-wide.

According to the Centers for Disease Control and Prevention ("CDC"), secondhand smoke contains more than 7,000 chemicals - hundreds of which are toxic to humans and 70 that can cause cancer. An estimated 2.5 million non-smoking adults have died since 1964 due to the adverse effects of secondhand smoke. Numerous health problems are associated with exposure to secondhand smoke, particularly in women and infants, including more severe and frequent asthma attacks, ear infections, respiratory infections and sudden infant death syndrome ("SIDS").

HHSC is in the business of providing quality healthcare services to the communities we serve. Allowing tobacco and electronic smoking device usage at our facilities is in direct conflict with the nature of our operations. Passage of this bill would ensure that our patients, employees, and visitors are protected at all times from exposure to secondhand smoke. Moreover, HHSC would be able to promote positive, healthy practices, and lead by example.

1 **Fiscal Implications:** None to the Department of Health.

Department Testimony: The Department of Health (DOH) supports SB0305 HD1 which
prohibits tobacco or electronic smoking device (ESD) use on all Hawaii Health Systems
Corporation (HHSC) premises. This measure has definitions for tobacco and ESD that are
consistent with §328J-1, HRS.

6 SB0305 HD1 would provide a tobacco-free environment on the HHSC premises 7 consistent with the policies already in place across hospital systems in Hawaii. According to the 2006 U.S. Surgeon General's Report on involuntary exposure to tobacco smoke, "there is no safe 8 level or amount of exposure to secondhand smoke." The report further states that hospitals with 9 tobacco-free policies are particularly effective, because they protect patients from secondhand 10 smoke exposure, project a positive, healthy image, send a consistent message, and encourage and 11 support tobacco use cessation among both patients and staff. The 2014 Centers for Disease 12 Control and Prevention publication, "Best Practices for Comprehensive Tobacco Control 13 Programs" likewise reaffirms that, "Systems changes within health care organizations 14 complement interventions in state and community settings by institutionalizing sustainable 15 16 approaches that support positive individual behavior change."

My name is Paula Yoshioka, and I am a Senior Vice President at The Queen's Health Systems (QHS). I would like to express my **support** for SB 305, SD1, HD1, Relating to Use of Tobacco Products and E-Cigarettes on Hawaii Health Systems Corporation Premises. This bill prohibits the use of tobacco products and electronic smoking devices (ESDs) on the premises of Hawaii Health Systems Corporation (HHSC) facilities.

In 2006, QHS instituted a ban on the use of tobacco products on our premises. Thank you for the opportunity to submit testimony in <u>SUPPORT</u> of SB305, SD1, HD1 which prohibits the use of tobacco products and electronic smoking devices on the premises of Hawaii Health Systems Corporation facilities.

The Coalition for a Tobacco-Free Hawai'i (Coalition) is a program of the Hawai'i Public Health Institute (HIPHI) that is dedicated to reducing tobacco use through education, policy, and advocacy. With nearly two decades of history in Hawai'i, the Coalition has led several campaigns on enacting smoke-free environments, including being the first state in the nation to prohibit the sale of tobacco and electronic smoking devices to purchasers under 21 years of age.

The Coalition supports a system-wide tobacco-free policy for Hawai'i Health Systems Corporation.

Smoking and tobacco use contribute to a wide range of institutional costs. These costs include employee absenteeism, extensive health care costs and increased medical insurance costs, fire risk, negative environmental impacts, and increased cleaning and maintenance costs.

Furthermore, secondhand smoke is dangerous; even brief exposure can be harmful to your health. Most exposure to secondhand smoke occurs in homes and workplaces, and over 2.5 million people have died from secondhand smoke. Nonsmokers who are exposed to secondhand smoke are at higher risk for heart disease and lung cancer. Secondhand smoke contains 7,000 identifiable chemicals, 70 of which cause cancer.



The Coalition supports the inclusion of electronic smoking devices in the proposed smoke-free policies.

In 2015, the State Legislature passed HB 940 (Act 19) which now includes ESDs in the statewide smoke-free air law (HRS § 328J). ESDs contain harmful ingredients such as nicotine and cancer-causing chemicals that are inhaled by those exposed to e-cigarette aerosol. As new tobacco laws are passed it is important to include ESDs as the aerosol emitted from ESDs contain harmful chemicals.

Many people live and work in Hawai'i for its clean air and lush surroundings. As a leader in its smoke-free laws, Hawai'i must continue to protect the public and its workers from the harmful impacts of secondhand smoke.

We support SB305, SD1, HD1 and urge you to pass this measure out of committee.

The Hawaii Government Employees Association, AFSCME Local 152, AFL-CIO has no objections to S.B. 305, S.D. 1, H.D. 1, which prohibits the use of tobacco products and electronic smoking devices on the premises of Hawaii Health Systems Corporation facilities.
