1 **Fiscal Implications:** None to the Department of Health.

2 Department Testimony: The Department of Health (DOH) supports the Committee's offered

3 Proposed HD1 of SB0305, SD1, which prohibits tobacco or electronic smoking device (ESD)

4 use on Hawaii Health Systems Corporation (HHSC) premises. The Proposed HD1 has

5 definitions for tobacco and ESD that are consistent with §328J-1, HRS.

6 The measure, SB0305, SD1, Proposed HD1 would provide a tobacco free environment in 7 the HHSC premises consistent with the policies already in place across hospital systems in Hawaii. According to the 2006 U.S. Surgeon General's Report on involuntary exposure to 8 tobacco smoke, "there is no safe level or amount of exposure to secondhand smoke." The report 9 further states that hospitals with tobacco-free policies are particularly effective, because they 10 protect patients from secondhand smoke exposure, project a positive, healthy image, send a 11 consistent message, and encourage and support tobacco use cessation among both patients and 12 staff. The 2014 Centers for Disease Control and Prevention publication, "Best Practices for 13 Comprehensive Tobacco Control Programs" likewise reaffirms that, "Systems changes within 14 health care organizations complement interventions in state and community settings by 15 institutionalizing sustainable approaches that support positive individual behavior change." 16

According to the Centers for Disease Control and Prevention ("CDC"), Cigarette smoking harms nearly every organ of the body, causes many diseases, and reduces the health of smokers in general. More than 10 times as many U.S. citizens have died prematurely from cigarette smoking than have died in all the wars fought by the United States during its history. Smoking causes about 90% of all lung cancer deaths in men and women. About 80% of all deaths from chronic Obstructive pulmonary disease (COPD) are caused by smoking. Smokers are more likely than nonsmokers to develop heart disease, stroke, and lung cancer. In addition, second hand smoke causes immediate harm to nonsmokers who breathe it.

HHSC is in the business of providing quality healthcare services to the communities we serve. Allowing tobacco and electronic smoking device usage at our facilities is in direct conflict with the nature of our operations. The State of Hawaii has taken a lead role in this battle for the health of our citizens by banning the use of tobacco products and electronic smoking devices in all enclosed or partially enclosed areas open to the public. Thank you for the opportunity to submit testimony in <u>SUPPORT</u> of SB305, SD1, proposed HD1 which prohibits the use of tobacco products and electronic smoking devices on the premises of Hawaii Health Systems Corporation facilities.

The Coalition for a Tobacco-Free Hawai'i (Coalition) is a program of the Hawai'i Public Health Institute (HIPHI) that is dedicated to reducing tobacco use through education, policy, and advocacy. With nearly two decades of history in Hawai'i, the Coalition has led several campaigns on enacting smoke-free environments, including being the first state in the nation to prohibit the sale of tobacco and electronic smoking devices to purchasers under 21 years of age.

# The Coalition supports a system-wide tobacco-free policy for Hawai'i Health Systems Corporation.

Smoking and tobacco use contribute to a wide range of institutional costs. These costs include employee absenteeism, extensive health care costs and increased medical insurance costs, fire risk, negative environmental impacts, and increased cleaning and maintenance costs.

Furthermore, secondhand smoke is dangerous; even brief exposure can be harmful to your health. Most exposure to secondhand smoke occurs in homes and workplaces, and over 2.5 million people have died from secondhand smoke. The International Agency for Research on Cancer and the U.S. Environmental Protection Agency both note that environmental tobacco smoke (or secondhand smoke) is carcinogenic to humans. Secondhand smoke contains 7,000 identifiable chemicals, 70 of which cause cancer.



Many people live and work in Hawai'i for its clean air and lush surroundings. As a leader in its smoke-free laws, Hawai'i must continue to protect the public and its workers from the harmful impacts of secondhand smoke.

We support SB305, SD1, proposed HD1 and urge you to pass this measure out of committee.

On behalf of the Hawaii Health Systems Corporation (HHSC) Corporate Board of Directors, thank you for the opportunity to present testimony in **strong support of SB305, SD1**, **Proposed HD1**, that prohibits tobacco and electronic smoking device usage on HHSC campuses state-wide.

According to the Centers for Disease Control and Prevention ("CDC"), secondhand smoke contains more than 7,000 chemicals – hundreds which are toxic to humans – and 70 that can cause cancer. An estimated 2.5 million *non-smoking* adults have died since 1964 due to the adverse effects of secondhand smoke. There are numerous health problems associated with exposure to secondhand smoke, particularly in women and infants, including more severe and frequent asthma attacks, ear infections, respiratory infections and sudden infant death syndrome ("SIDS").
