RELATING TO AN AIRPORT AUTHORITY

Senate Bill No. 3072, S.D. 1, proposes to establish the Hawaii Airport Authority (HAA) which shall be a body politic and corporate, constituting a public instrumentality and a special political subdivision of the State, created for the performance of an essential public and government function, as provided in the bill. The authority shall be established and operate as an independent subdivision of the State and shall not be construed to be a department, institution, or agency of the State. To accomplish this task, the measure transfers the jurisdiction over aeronautics and airports, including airport functions under the Department of Transportation's (DOT) Airports Division, to the HAA on July 1, 2018. The bill also provides an unspecified general fund appropriation for Fiscal Year 2016-2017 for the implementation and operation of the HAA.

The Department of Budget and Finance strongly opposes this measure. DOT is currently in the process of exploring the feasibility of establishing an airport authority. This feasibility study has not been completed, nor has any follow-up analysis been conducted of the benefits and challenges of establishing such an authority. Considering the complexity and magnitude of the operations of the State's airports, it would be prudent to review the airports authority feasibility study first, then determine the best course of action for the State.

S.B. 3072, S.D. 1 RELATING TO AN AIRPORT AUTHORITY

Senate Committee on Ways and Means

The Department of Transportation (DOT) **strongly supports** S.B. 3072, S.D. 1 and appreciates the recommendations by the standing committee on Senate Draft 1 which clarifies and strengthens the attributes for the Hawaii Airport Authority to be fully effective by outlining 10 objectives:

- 1. Increasing security for the State;
- 2. Providing an appropriate forum for all affected interests;
- 3. Increasing efficiency in land use and related lease processes;
- 4. Improving administrative efficiency by streamlining administrative processes;
- 5. Coordinating environmental issues affecting the airports, particularly relating to alien invasive species. As an airport authority it will be able to oversee everything that enters the State by air, thereby allowing that entity to serve as the agency responsible for comprehensive alien invasive species protection and control;
- 6. Increasing economic opportunities for the State in collaboration with the Hawaii Tourism Authority;
- 7. Making possible more responsive planning;
- 8. Increasing financial flexibility;
- 9. Increasing responsiveness to customer needs and economic demands; and
- 10. Improving the efficiency and expedience of the airports capital improvement program implementation.

The DOT believes the Hawaii airport authority would benefit the State of Hawaii with one jurisdiction having overall authority to efficiently manage and allocate statewide resources, as appropriate, to improve the airport facilities and operations.

Hawaii's airports operate as an enterprise and have never required general funds to operate and implement their programs. As such, the DOT request that Section 12 be removed from the bill as passage of this important bill will require no general funds as

The Beneficiary Advocacy and Empowerment Committee of the Office of Hawaiian Affairs (OHA) will recommend to the OHA Board of Trustees a position of <u>COMMENT</u> on SB3072 SD1, which proposes to establish the Hawai'i Airport Authority, to provide coordinated planning, operations, and development of the State's airports and aeronautical facilities.

OHA appreciates the intent of establishing a Hawai'i Airport Authority (Authority). However, OHA notes that the wording of this measure leaves unclear the legal nature and status of the proposed Authority, in a manner that could affect the rights of OHA and our Native Hawaiian beneficiaries.

Section -2 of the measure variously describes the new Authority as:

-a "body politic and corporate";

-a "public instrumentality";

-a "special subdivision of the State";

-"not . . . a department, institution, or agency of the State"; and

-an "independent subdivision of the State."

These varying descriptions raise questions regarding whether key laws of great importance to Native Hawaiians would apply to the Authority. These laws include, for example, Act 178, Session Laws of Hawai'i 2006, which imposes strict public land trust revenue accounting requirements on state departments and agencies that use or manage public lands. Another example is Chapter 171, Hawai'i Revised Statutes, which contains numerous provisions on the disposition of public lands, including the requirement that legislative approval be obtained prior to the sale or gift of state lands. See HRS §171-64.7. Should this measure move forward, OHA urges the Committee to ensure that such laws be made clearly applicable to the Authority in its administration and disposition of lands under its control.

As the saying goes, "You never get a second chance to make a first impression". Our State's main economic engine is the Visitor Industry. The first impression of our state happens at the airport. Every touch point of a visitor's experience should be impeccable. To remain a world class visitor destination, our goal should be to have the airport experience mirror the hotel experience. Today these two are worlds apart. Kauai, Maui and Hawaii Island's airports are in need of basic repair and quality maintenance. Next time you fly in or out of these airports, take a good look around. Note the condition of the ceilings, bathrooms, floors, carpets, windows, seats, flight monitors, etc... I flew into Sacramento, CA airport over the summer. It was impressive and immaculately clean.....Sacramento, CA.

In the US, only two other States, Alaska and Washington airports are owned and operated by government departments, like Hawaii. The reason is productive efficiency and profitability. The state's management is the root cause. So spread out and inefficient currently.
