SUBJECT: S.B. 3080, RELATING TO THEFT

My name is Lisa Wond and I support S.B. 3080.

Last June, thieves broke into the gravesite of my grandfather, my grandmother, my aunt and my uncle, and stole their urns. The thieves took the urns to Reynolds Recycling, and received \$31. For them, it was a way to make money.

For our family, it was heartbreaking. We canvassed the graveyard and surrounding areas, but the ashes of my family members were never recovered. In Hawaii, where we respect our elders and honor our ancestors, what the thieves did to our family was unbelievable. They stole much more than the urns and ashes of our loved ones. We mourn for a second time the loss of our family members. My mom has had many sleepless nights over the loss of her parents' ashes and what we thought was their final resting place. We are unable to continue our family's culture and tradition of taking our children and grandchildren to visit our family gravesite, knowing that it lies empty. I feel violated and angry that anyone could commit such desperate and selfish acts against us, for \$31. Peace of mind? It's something I haven't had since last June.

While we support making the theft of urns a Class C felony, we also believe that Reynolds' Recycling had a major role in perpetuating this act against our family. We would like to see enforceable provisions included in this bill that address the role of the recycler. For example, prohibiting the sale of urns to recyclers, and prohibiting the purchase of urns by recyclers, with penalties against a recycler who accepts or pays for urns would very likely eliminate the need for thieves to ever steal another urn.

It is a sad statement of our social condition when we have to enact laws to prevent people from stealing the urns of the deceased. But I fully support this bill, with the hope that it will deter thieves enough to prevent other families from experiencing what we are enduring.
