A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF BUSINESS, ECONOMIC DEVELOPMENT, AND TOURISM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that duplicate agency 2 programs result in an ineffective use of resources. Inter-3 agency agreements provide agencies with an opportunity to 4 streamline and expedite agreements through the coordination of 5 resources and elimination of unnecessary duplication, without 6 entering into a memorandum of agreement or memorandum of 7 understanding.

8 The purpose of this Act is to require that state agencies 9 implement inter-agency agreements without entering into a 10 memorandum of agreement or memorandum of understanding.

SECTION 2. Chapter 201, Hawaii Revised Statutes, is amended by adding a new section to be appropriately designated and to read as follows:

14 "<u>\$201-</u> Inter-agency agreements; memoranda of agreement;
15 memoranda of understanding. (a) The department of business,
16 economic development, and tourism shall develop, and any state
17 agency, shall enter into, and implement inter-agency agreements

The Department of Business, Economic Development, and Tourism (DBEDT) supports SB 3102, SD1, which allows DBEDT to enter into and implement inter-agency agreements to coordinate resources, eliminate unnecessary duplication, and generally effectuate the purpose of Chapter 201, without entering into a memorandum of agreement or memorandum of understanding.
