I'm Ron Han, Director of the State Office of Veterans Services. I appreciate this opportunity to provide testimony in support of Senate Bill 3112 as long as its implementation does not impact or replace the priorities set forth in the Executive Budget.

Thank you chairman and vice chairman of this committee for this opportunity to **strongly support HB3112**. This measure appropriates funds for the programs, ceremonies and activities commemorating the 50<sup>th</sup> Anniversary of the Vietnam War and Hawaii's veterans who served both in country and within the Era.

I am a decorated Vietnam Veteran that served 2 tours as a Captain in the US Army Nurse in the height of the war. I am a 1968 TET Offensive survivor. I also am a member of the 50<sup>th</sup> Anniversary Committee. When I was asked to be on this committee, my first thought was "HA!!! Too little, too Late" but then I thought about it and said, "OK, Better Late than Never".....

I want to tell you that WAR is HELL.... Anyone that has been in a combat zone will agree with me.... And I hope you or your family members have to be in that situation. Those young men and women that were in that hell zone and came home alive had another hell to face once they got home.....They were spit on, called baby killers, and other horrendous things....I was fortunate like some other young women coming home, even though we came home in uniform, most people

didn't think we were coming back from Vietnam and didn't treat us so horribly bad when we landed at our home airport.

This measure will afford Hawaii to honor all military members, their families, and other government and non-government organization which supported our effort during the Vietnam War. As I stated we were not given an appropriate "Welcome home" and as this the 50th Anniversary of the War it is fitting to recognize these individuals and their family members while they are able to receive the recognition.

I am a 50<sup>th</sup> Anniversary committee member. I am also the person responsible for setting up concerts as one of the events in May 2017. I am trying to have USO Arlington work with us to pick up the entire cost of the entertainment but if we don't meet their criteria, USO Hawaii will pick up the cost of the entertainers ( several groups of the 60's) but we will have to pay for the travel along with room and board. We are considering having this function at the Aloha Stadium, the Shell or the Kaneohe Marine Base. We will also need to bus the veterans to and fro either of the aforementioned locations

I thank the committee for allowing me this opportunity to testify in strong support of this bill.

Aloha Committee Chair and Members:

I write in support of SB 3112, the Bill Relating to the Vietnam War Commemoration.

Our nation is officially in the "Commemoration Window" of remembrance of the Vietnam

War and of those who served their country during that period. As you may know, Hawaii was

was central to the conflict, as the Kaneohe Marines and soldiers of the 25th Infantry Division

were among the first to deploy to the combat zone. I know personally as I deployed with the

25th in 1965.

Throughout the long war, Hawaii served as a Rest and Recuperation (R&R) location for

deployed troops to meet their spouses, families, and friends. Many veterans today recall

that short 6-7 day respite in Hawaii with great warmth and genuine nostalgia. I have heard

the stories repeatedly when old friends visit and they recall the R&R days on the beach, the

Don Ho show, where they stayed, etc. It was a respite filled with happy memories.

Our state has an energetic committee, chaired by Colonel (Ret) Gene Castagnetti, USMC, that

is developing a commemorative program of activities to remind our state to remember and to

educate younger generations on that period in our history.

The Committee needs financial support to insure this program is offered and presented in the

appropriate manner so as to remember and honor. The Committee anticipates a significant

influx of veterans from around the country, as well as increased visits from veterans of other

nations (Australia, New Zealand, Korea, Thailand, and others), when the schedule of events are

announced.

I ask you to consider favorably SB3112 and shepherd it through to law. Mahalo.
