Re: Opposition to Senate Bill No. 331 Relating to Manoa Road

Thank you very much for the opportunity to present testimony in opposition to Senate Bill No. 331, which requires the State of Hawaii, Director of Transportation, to transfer ownership of that portion of Manoa Road from its intersection with Waakaua Street to Lyon Arboretum (the "Portion of Manoa Road") to the City and County of Honolulu ("City"). The bill also provides that that the conveyance of that portion of Manoa Road should occur and should be exempt from any state or county road standard requirements, including width.

The Portion of Manoa Road is privately-owned property belonging to Kamehameha Schools ("KS"), the Roman Catholic Church and others.

The City strongly opposes Senate Bill No. 331 for the following reasons:

- It is undisputed that title to the property is privately owned and has not been conveyed to the State of Hawaii nor to the City.
- There is no evidence that conclusively establishes that the Portion of Manoa Road is a government road. Therefore, the State does

> not own the Portion of Manoa Road, and the State Director of Transportation does not have the legal capacity to convey title to the subject property to the City.

• A private roadway cannot become a county highway without the express acceptance of the private road by the City Council. *Wemple ex rel. Dang v. Dahman*, 103 Hawai'i 385, 83 P.3d 100 (2004). Therefore, a conveyance by the State Director of Transportation of the Portion of Manoa Road would not confer jurisdiction over the roadway to the City for purposes of maintenance, repair and liability.

Therefore, the City opposes Senate Bill No. 331 because it contravenes the principles of private property ownership and the requirements for the City to accept roadways. The City strongly urges the Committees to vote no on Senate Bill No. 331.

Therefore, I believe, the director of transportation should transfer ownership to the City and County of Honolulu that portion of Manoa road in the City and County of Honolulu that extends north from the intersection with Waakaua street to the northern boundary of the parcel identified as TMK: (1)2-9-54:33 and the southeastern boundary of adjacent parcel identified as TMK: (1)2-9-54:7; provided that this portion of Manoa Road shall be exempt from any statute, rule, ordinance, or code requirement relating to minimum width; provided further that the city and county of Honolulu shall otherwise maintain the road as required by law.
