Chair Luke, Vice Chair Nishimoto, and Members of the Committee:

My name is Kamakana Kaimuloa, and I am the Vice President of Military Affairs at The Chamber of Commerce of Hawaii (The Chamber). The Chamber <u>supports</u> SB559, SD2, HD1.

In recognizing how critical the U.S. military presence is to Hawaii's economy, the Chamber officially established a military affairs department in 1985. For 30 years the Chamber, through its Military Affairs Council (MAC), has served as the State's liaison in matters relating to the military and has been steadfast in working to protect and preserve the military's presence in Hawaii, promote public awareness and understanding of issues facing the military locally and nationally, and serve as the advocate for military and their families.

As it is noted in the bill, the defense industry is responsible for generating \$14.7 billion into Hawaii's economy, making it the state's second major source of revenues, next to tourism. Moreover, the industry accounts for creating job opportunities for more than 100,000 Hawaii residents that report annual household earnings topping \$8.7 billion annually.

Despite these numbers, the State of Hawaii does not have a governmental entity that can analyze the impact of military spending, develop initiatives to target growth, or identify and advocate for possible funding sources from the federal government to protect local communities from the economic impact of military downsizing or base closure. Without the ability to perform these basic functions, Hawaii is at a considerable disadvantage, when compared to the governmental entities and respective budgets of other states. This became very evident most recently when all states/communities with army bases were called upon to demonstrate support for maintaining an army presence. The MAC was proud to lead the effort, but most definitely could have benefited significantly from state government partner. Competition for an ever-shrinking pool of defense dollars will only continue into the future. We need to remain vigilant.

While the Chamber remains committed to serving in this role, its effectiveness is limited by both funding and its status as a non-profit business organization. Although the Chamber receives some funding from the state through the grant-in-aid program, much of the Chamber 's initiatives are self-funded. Additionally, the Chamber is actively searching for grants from federal agencies to fund the possible initiatives listed above, but it would be the State that ultimately would need to develop a formal relationship with these agencies should grant money become available.

While our preference was to place staff in the Office of the Governor to execute the responsibilities outlined in this legislation, we recognize that there are statutory impediments that prevent such a preference from occurring if this legislation is the only viable way to reach the desired outcome. In closing, we humbly ask you to pass this measure and look forward to continuing the discussion.

The Department of Hawaii, Veterans of Foreign Wars of the United States (VFW) represents 3,800 members in 20 Posts located throughout the State of Hawaii. VFW is a federally chartered national association of soldiers, sailors, marines and airmen who have served the United States of America in wars, campaigns, and expeditions on foreign soil or in hostile waters.

S.B. 559 SD2 HD1 Establishes and funds a Military Affairs Advisor position who reports directly to the Governor and an Assistant Military Affairs Advisor position in the Department of Defense. (SB559 HD1)

VFW Hawaii concurs with the amendments of the Committee on Veterans, Military, & International Affairs, & Culture and the Arts that: (1) deleted the provisions relating to expanding the role of the Office of Veterans' Services; (2) established a Military Affairs Advisor position and an Assistant Military Affairs Advisor position within the Department of Defense, with the Military Affairs Advisor reporting directly to the Governor; (3) specified the functions, duties, and powers of the new positions; (4) appropriated funds to establish the new positions in the Department of Defense; and (5) changed its effective date to upon its approval.

VFW Hawaii members would appreciate your favorable consideration of this measure because it would more clearly align the roles of advising the Governor on Military Affairs to new positions within the Department of Defense rather than within an expanded Office of Veterans Affairs.

Thank you for this opportunity to testify in support of S.B. 559 SD2 HD1.
