Chair Ito, Vice Chair Tokioka and Committee Members:

I'm Ron Han, Director of the State Office of Veterans Services (OVS). I appreciate this opportunity to provide testimony and comments in support of the concepts in Senate Bill 559, SD2.

This measure seeks to expand the State Office of Veterans Services to include a military affairs function and to appropriate funds needed for the increase in responsibilities and roles for this new mission. SD 2 provides some insight on these roles on pages 10-11 of the measure, but does not quantify the full-time employment (FTE) authorizations or the types of personnel classifications it would take to meet mission goals and objectives. Since the core is servicing Veterans with benefits counseling and support to the eight State Veterans Cemeteries, we believe the new name should reflect State Office of Veterans Services and Military Affairs. This new office function will need to be more than just cosmetic changes in name only. Clearly defined roles and responsibilities must be developed and addressed to include FTE and proper funding before absorbing any responsibilities to preclude future mission degradation or failure. Additionally the OVS will need to work with the Human Resource staff to determine the function of these added position(s) and the level of compensation. In foresight, this function and position(s) could serve as a catalyst for interacting and collaborating with the respective military service components, to explore existing and future issues between the State and military, and to serve as a liaison on subjects requiring coordination with State and military agencies.

The OVS supports the intent expressed in this measure as long as its implementation does not impact or replace the priorities set forth in the Executive Budget for Fiscal Biennium 2015-2017.

### RE: SB559, SD2: RELATING TO THE MILITARY

Chair Ito, Vice Chair Tokioka, and Members of the Committee:

My name is Kamakana Kaimuloa, and I am the Vice President of Military Affairs at The Chamber of Commerce of Hawaii (The Chamber). The Chamber <u>supports</u> SB559, SD2.

In recognizing how critical the U.S. military presence is to Hawaii's economy, the Chamber officially established a military affairs department in 1985. For 30 years the Chamber, through its Military Affairs Council (MAC), has served as the State's liaison in matters relating to the military and has been steadfast in working to protect and preserve the military's presence in Hawaii, promote public awareness and understanding of issues facing the military locally and nationally, and serve as the advocate for military and their families.

As it is noted in the bill, the defense industry is responsible for generating \$14.7 billion into Hawaii's economy, making it the state's second major source of revenues, next to tourism. Moreover, the industry accounts for creating job opportunities for more than 100,000 Hawaii residents that report annual household earnings topping \$8.7 billion annually.

Despite these numbers, the State of Hawaii does not have a governmental entity that can analyze the impact of military spending, develop initiatives to target growth, or identify and advocate for possible funding sources from the federal government to protect local communities from the economic impact of military downsizing or base closure. Without the ability to perform these basic functions, Hawaii is at a considerable disadvantage, when compared to the governmental entities and respective budgets of other states. This became very evident most recently when all states/communities with army bases were called upon to demonstrate support for maintaining an army presence. The MAC was proud to lead the effort, but most definitely could have benefited significantly from state government partner. Competition for an ever-shrinking pool of defense dollars will only continue into the future. We need to remain vigilant.

While the Chamber remains committed to serving in this role, its effectiveness is limited by both funding and its status as a non-profit business organization. Although the Chamber receives some funding from the state through the grant-in-aid program, much of the Chamber's initiatives are self-funded. Additionally, the Chamber is actively searching for grants from federal agencies to fund the possible initiatives listed above, but it would be the State that ultimately would need to develop a formal relationship with these agencies should grant money become available.

We are persuaded by the Ways and Means Committee Chair's notation that there may be another place for a Military Affairs Advocate to reside, particularly because there has not yet been an FTE and budget proposed. While an option is clearly the Office of Veterans Services, it could also be placed in the Governor's Office, the Department of Business, Economic Development and Tourism, or the Department of Defense. We look forward to continuing the discussion.
