Chairpersons Ruderman and Thielen and Members of the Committees:

Thank you for the opportunity to testify. ADC supports the intent of Senate Bill No. 593 which requires the Agribusiness Development Corporation (ADC) to make increasing agriculture and local food production its primary mission; establish a sustainable agriculture and local food production plan; submit annual reports to the legislature; and lease 50 percent of its land to operations that support increasing agriculture and local food production within the next ten years.

Increasing diversified agriculture and local food production on its farmable land is one of ADC's top priorities. To date, ADC manages roughly 10,000 acres of agricultural lands on the Island of Kauai and Oahu that are considered farmable, of which 9,000 acres are on Kauai.



On Oahu, much if not all of the 1,200 acres of Galbraith lands will be licensed to established local food growers for food production. ADC is currently developing a water system on the Galbraith land to support multiple diversified agriculture operations, which includes small family farms. Without an adequate water source, these farmers will not be able to cultivate the land at maximum capacity.

On the Island of Kauai, ADC has available lands in Kekaha and Kalepa. To lower the cost of diversified agriculture production and maximize the use of its farmable lands, ADC established an intercropping program in Kekaha that allows local food growers to share 5,000 acres with the larger companies. Since implementing the program, local food growers from the neighbor islands have expanded their operations to Kekaha and are currently growing sweet potato, ginger, and green beans. In Kalepa, ADC has set aside approximately 960 of its 4,500 acres of farmable land specifically for diversified agriculture. While there is tremendous potential on the island for local food production, there is an apparent shortage of experienced farmers.

Accessing water and the lack of farmers is not just an ADC issue. These challenges combined with the soaring cost of agricultural land and long-term leases will continue to inhibit the growth and expansion of local agriculture unless statewide policies that encourages farming rather than restricting it are implemented.

While ADC envisions its land playing a significant role in supporting our State's sustainable agriculture and food self-sufficiency in the near future, ADC cannot achieve these goals alone given our limited land and resources. If the intent is to significantly

impact the amount of imported food to the islands and increase Hawaii's local food production, then the goals set forth in this bill should apply to all agricultural lands, public and private, and not just to the limited land of a single agency.

Aloha Chairs Ruderman and Thielen, Vice-Chairs and Members of the Committee,

My name is Bart Dame and I am testifying on behalf of Progressive Democrats of Hawaii in strong support of this measure.

PDH agrees there is a legitimate public interest in encouraging the growth of sustainable and local food production on lands controlled by the state. And we believe the state has an interest in providing extra support to nurture such operations.

We believe one of the biggest obstacles to small farmers is the lack of access to affordable land with leases long enough to justify building up the soil and investing in otherwise increasing the productivity of the land. Few private landowners are willing to encumber there lands with longterm leases because they feel a need to be able to sell off or develop their ag lands for more profitable returns if and when market conditions allow for residential, commercial or resort development. As a result, the price of most ag land is inflated to reflect its future market value as non-ag lands.

This is where the state can assist farmers and potential farmers by making land available at low cost. The ADC is doing this, but almost all the leases are going to large agricultural operations engaged in agricultural practices we view as unsustainable and for non-food production, The biggest tenants appear to be the transnational chemical companies developing genetically engineered seed corn.

Meanwhile, small, local farmers trying to grow food for local consumption, are not being provided leases on ADC-controlled land. We believe the legislature should make a policy decision to remedy this by mandating 50% of leases be shifted to sustainable production of food. With the proper nurturance by the state, we believe such agriculture will blossom. ADC can serve as a "greenhouse" for sustainable, local food production.

We suggest the bill could be strengthened by defining "sustainable" agriculture. We defer to others on how to do that.

We strongly urge the committee to pass SB 593.

## Aloha,

My name is Gary Hooser I presently serve on the Kauai County Council and I am here today testifying in strong support of SB593 Relating to Agriculture.

Suggested Amendments:

- 1) Suggest that the term "sustainable agriculture" be clearly defined and the federal definition as detailed below be used as a basis.
- 2) Suggest also that in the line "Local food production means crops, livestock, poultry, and other foods that are grown and raised on in Hawaii primarily for consumption by Hawaii residents and visitors." further clarity be offered to the word "primary" as in perhaps more than 50% of the value of the agricultural operation. The objective being not to discourage exports but rather to make it clear that the #1 priority is local food production.
- 3) Strongly suggest that the requirement that the land be used for "sustainable agriculture and local food production" be continuously linked as both requirements are essential elements of this legislation.

SB593 requires the Agribusiness Development Corporation (ADC) to develop and implement a plan so that by December 31, 2025, a minimum of 50 per cent of lands of the lands controlled by them shall be leased to operations that support sustainable agriculture whose primary business is the production of food for local consumption in Hawaii. SB593 also includes "reporting requirements" which are essential in order for the public to know how their public lands are being managed.

Translation: If SB593 is passed into law - it is possible that over the next 10 years over 10,000 acres of public agricultural lands would be made available to local farmers for sustainable agriculture and local food production.

The passing of SB593 could thus be a "game changer" for food self sufficiency in Hawaii.

I have served for over 15 years in public service and have heard the talk about food self sufficiency that entire time. I was one of the original members of the 2015 Sustainability Task Force initiated by then Senator Russell Kokubun.

Feeding ourselves, food security, food self sufficiency and sustainability have been lofty goals and objectives that all policy makers in all bodies of government have professed to support.

SB593 represents a tangible opportunity to finally and unequivocally move this agenda forward.

I have reviewed numerous "agricultural development plans" over the years.

Each and every plan always cites that lack of affordable long term leases of good agricultural land as a major roadblock to expansion. While there are other impediments such as infrastructure, labor and marketing – the availability of land is literally the foundation upon which all is based.

The Agribusiness Development Corporation (ADC) controls over 20,000 acres of agricultural public lands, *yet only a tiny portion of ADC lands are used for local food production*.

As a Councilmember I have tried to find out exactly how much of their land is used for local food production but the answer I received was that they do not know. This alone shows clearly the need for regular reporting requirements as to how those public lands are being used.

Even though the exact numbers are not available to me, it is clear that on Kauai the vast majority of the ADC lands are leased to large corporations who do not produce food for local consumption, nor do these corporations practice sustainable farming methods.

Sustainable agriculture is defined by the Federal Government as:

"An integrated system of plant and animal production practices having a site-specific application that over the long-term will:

- satisfy human food and fiber (and energy/biomass) needs;
- enhance environmental quality and the natural resource base upon which the agricultural economy depends;
- make the most efficient use of nonrenewable resources and on-farm resources and integrate natural biological cycles and controls;
- sustain the economic viability of farm operations;
- enhance the quality of life for farmers and the community/society as a whole.

Thus, the official, or legal, federal definition has five parts, emphasizing productivity, protection/enhancement of environmental quality, efficient use of nonrenewable

resources, economic viability and improving the overall quality of the farming community. Under this definition, a farm that emphasizes short-term profits, but sacrifices environmental quality, would not be sustainable in the long-run. In contrast, pursuing environmental quality without ensuring viable short-term economic returns would also not be sustainable. A farm that is very productive but uses large amounts of fossil fuels, nonrenewable resources, or a non-rechargeable aquifer, or one that pollutes the aquifer with farm wastes or toxic chemicals to achieve and maintain that productivity would not be considered sustainable in the long-run.

# **Testimony in support of SB593**

# Concerning the Agribusiness Development Corporation. John Zwiebel

I am writing in support of Senate Bill 593. Hawaii is extremely vulnerable to the cut off of food since 90% of the food consumed is imported into the state. Most of this food is processed by large conglomerates that are more concerned with making a profit than in providing nutritious food. There is an epidemic of childhood obesity in our country. There is a rise in several diseases, including: celiac disease (gluten intolerance); diabetes; leaky gut syndrome and autism. A recent study has shown a correlation between depression and the consumption of processed foods that are high in sugar content. While it is true that the scientific evidence supporting these correlations may not be conclusive, it is enough for many individuals to seek out alternatives and, in some cases, even grow their own food. As an example, the Cost-U-Less in Kapaa has greatly expanded its offering of organically certified food. We now often make the trip from Kalaheo by-passing Costco.

If Hawaiian grown food was available, we would go out of our way to obtain it. All of our meat comes from Mederios in Kalaheo. We often attend the farmer's markets, but we are suspicious that much of the food being offered is resale from Costco. We can taste, if not see, the difference. We grow our own lettuce, beans, citrus, tomatoes, cassava, avocado, lychee, mac nuts, and cacao. Our attempts to grow enough for sale, even at a farmer's market, have proven to be futile because of the labor involved.

- We graduated from a gardening class at KCC where we met others who have put a lot of time and effort into growing their own. We found our instructors most knowledgeable and tireless in their efforts to grow food, but also up against insurmountable odds. We have a neighbor who has devoted years into food production, who supplies the local restaurants, but who has yet to make a profit.
- My father was heavily involved in crop production in my hometown. Back in 1965, a farmer could make a decent living on 80 acres. Now that farmer must control over 3000 acres. The canning company in my hometown has had 12 different owners since 1989. The truck farms that used to supply the vegetables for that company have mostly gone out of business. I tell you this because Bill 593 doesn't nearly go far enough to achieve its objectives.

If this bill is going to be successful, it needs to address several issues.

- Who is going to be able to farm the ABDC land?
- How many acres will each farmer be allotted?
- Will the state set up price supports for the farmer's crop?
- Will the state establish cooperatives that can assist each farmer in choosing the crop to plant and how to best market that crop?
- How will the state ensure that the crop will be sold?

- How does the state plan on marketing these new foods to the Hawaiian consumer?
- Which retail outlets in the state have committed to distribution of this crop?
- Which farm organizations have been contacted to support this bill?
- Will this program be funded for a long enough period to ensure its success? (For example, with the restriction lifted on Avocado export to the mainland, will finding be available for a long enough period to ensure the success of the farmer who plants trees this year?)

Support of home-grown Hawaiian food is obvious. The question is whether or not the legislature will maintain that support or be distracted by funding requirements of boondoggles like HART (too big, using technology that was obsolete before it was voted on) or the Super-Ferry (moving personal automobiles is hardly an efficient use of energy).

I am a cultural anthropologist who has invested over 20 years in supporting the health and well being of young children and their families in Hawaii by partnering with public and private agencies including the Hawaii State Department of Health, UH JABSOM Department of Pediatrics, American Academy of Pediatrics/Hawaii Chapter, community health centers, and early childhood organizations in the areas of health, early learning, family engagement and support. I have also co-founded small businesses with Sharon Taba, MEd, Webfish Pacific, LLC & Same Small Boat Productions, LLC, that have received federal, state, and foundation support to develop projects supporting young children and their families.

I am writing to urge you to <u>support</u> **SB593: Relating to Agriculture** and the Agribusiness Development Corporation, introduced in the Senate by Senators Ruderman, Espero, Gabbard, Green, Riviere, and Thielen.

This proposed law would:

- 1) Make ADCs primary mission "increasing agriculture and local food production";
- 2) Establish a sustainable and local food production plan; and,
- 3) Lease 50% of its land to operations that support increasing agriculture and local food production.

Because over 85% of Hawaii's food is imported, I believe:

- This bill is important because families and communities across Hawaii need more access to sustainable and local food alternatives rather than remaining vulnerable to natural disasters and global events that may disrupt our imported food supply;
- 2) Young children and their families will only benefit from increased access to sustainable, local, and cost-effective alternatives to imported food.

With increased numbers of local farmers and ranchers having access to affordable leases on good agricultural lands, Hawaii's economy will be strengthened by expanding the workforce in small, sustainable agricultural concerns and by families investing significantly more resources in food that is grown right here in Hawaii.

I understand there are bills during this legislative session such as utilities, hospitals, rail, and pensions that represent big budget concerns demanding your immediate attention. However, we cannot forget the smaller, "quieter" issues that will end up being just as important to the health and well being of *all* children and families across the state. Dear Senator Ruderman, Senator Riviere, Senator Thielen, Senator Galuteria and members of the Committees:

This bill, in conjunction with community and farm efforts, could be a significant fist step to improving the sustainability of agriculture in Hawaii.

The bill appears to be well-crafted to start with. I do have some suggestions.

1. **Remove "and visitors"**, page 2 line 11. Let them eat sushi. We need to have sustainable agriculture—and low-cost food—for ourselves first. It would be too bad if our best tomatoes end up in pasta sauce served at the big hotels.

2. We also want our sustainable agriculture to respond to the needs of residents—which means we may need **more and larger farmers markets** (where many items are already cheaper than in supermarkets) and to **have them accept food stamps** (SNAP). That's important to keep the money circulating in Hawaii and in effect brings in federal funds to help support the sustainable agriculture effort.

As a matter of pubic policy, citizens should be able to purchase those tomatoes at the farmers markets as well as in local supermarkets. Farmers markets similar to the current Farm Bureau model require that vendors sell only local products. These markets assure that farmers will make a profit from their labors.

Accordingly, I recommend that this bill could further sustainability by urging the agribusiness development corporation to **deploy a certain number of farmers markets in some proportion to the acreage of new farms** that take advantage of the new sustainability efforts.

3. To the extent possible, as new farms develop, the plan should encourage the Department of Education to source school lunch ingredients from Hawaii's own farms. Children enjoying the taste of freshly picked produce will grow up to prefer Hawaii-grown produce to supermarket fast-food. If this happens to any extent, it serves to support the farm sustainability movement over the long term.

#### Aloha,

I am writing in support of passing SB593. This is a very important bill for our island of Kauai and for all of the Hawaiian islands. It is critical that more food be grown on our islands to support our local populations with fresh local produce to feed ourselves, to decrease our dependency on food shipped in from elsewhere and to keep jobs and money on the islands to support our state economy.

In support of passing this bill I offer the following information:

1) The Agribusiness Development Corporation (ADC) was supposedly created to help "transition Hawaii's agriculture industry . . . to one composed of a diversity of different crops." (ADC website). Yet, while ADC controls over 20,000 acres of agricultural public lands, *less than 5% of ADC lands are used for local food production*.

2) According to the Hawai'i 's (DBEDT) "Increased Food Security and Food Self-Sufficiency Strategy":Hawai'i urgently needs to become more self-sufficient and "food secure." At the moment 85-90% of Hawaii's food is imported which makes it particularly vulnerable to natural disasters and global event that might disrupt shipping and the food supply.

3) Local farmers and ranchers state lack affordable long term leases for farm land as the most important roadblock to expanding local food production

4) The vast majority of the over 20,000 acres of state owned agricultural lands that the ADC leases has been leased to non-food producing corporations for very long terms at very low rates. Which offer very monies to the county coffers and keep farmers from being able to produce food on these lands.

5) Requiring the ADC to develop and implement a plan to lease a minimum of 50% of the tillable public lands they manage within the next 10 years for sustainable agriculture and local food production is a reasonable approach to utilizing existing public lands to achieve our State's goal of increased food sustainability. After all they are public lands that are for serving the public good.

6) This would also benefit Hawai'i economically, creating thousands of jobs and infusing the economy with millions of dollars. As outlined by Hawai'i DBEDT's "Increased Food Security and Food Self-Sufficiency Strategy":

The economic impact of food import replacement is significant. Replacing just 10% of the food we currently import would amount to approximately \$313 million. Assuming a 30% farm share, \$94 million would be realized at the farm-gate which would generate an economy-wide impact of an additional \$188 million in sales, \$47 million in earnings, \$6 million in state tax revenues, and more than 2,300 jobs.

7) The public lands the ADC is managing are held in trust and are supposed to be used for the public good. Sustainable agricultural practices are important to restore and preserve the land for future generations, as opposed to pesticide-intensive industrial practices.

Thank you very much for your time and consideration in this matter. I strongly request that you support this bill and thus support the well-being of the people and aina of Hawai'i.
