Good afternoon Chair Espero, Vice-Chair Baker, and members of the Committee:

I'm Ron Han, Director of the State Office of Veterans Services (OVS). I appreciate this opportunity to provide testimony in support of Senate Bill 686 as long as its implementation does not impact or replace the priorities set forth in the Executive Budget.
