TESTIMONY ON SENATE BILL NO. 735, S.D. 1, RELATING TO NURSES.

TO THE HONORABLE ROSALYN H. BAKER, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is Lee Ann Teshima, Executive Officer of the Board of Nursing ("Board"). I appreciate the opportunity to submit written comments on Senate Bill No. 735, S.D. 1, Relating to Nurses, that would require licensed registered and licensed practical nurses to complete continuing competency requirements prior to the renewal of their nurse license beginning with the 2017 biennium, by completing a "learning activity".

The Board supports this bill with amendments:

- Page 2, line 13, amend title of the section to read as follows, "Continuing competency requirements; exemptions; extensions; records retention; audit." This clarifies the title to reflect the contents of the section.
- Page 2, lines 16-17, delete reference to "thirty contact hours". Thirty contact hours only pertain to the continuing education learning activity.
 The other learning activity options vary in hours. The intent of this bill is

for a nurse licensee to complete one of the learning activities, not only continuing education.

- Page 3, line 5, should include "practical nurses". This section exempts nurses who also maintain national nursing certification from the continuing competency requirements since national certifications already require continuing education in addition to other requirements. Licensed practical nurses may also obtain national certification and should be afforded the same exemption as a registered nurse with national certification.
- Page 3, lines 13-19, is amended to allow a new nursing graduate modified learning activity options in order to meet the continuing competency requirement that include only fifteen hours of continuing education, one semester credit of post-licensure academic education related to nursing practice from an accredited nursing program, or a learning activity that is approved by the Board.
- Page 4, line 19, is amended to include the words "to completion of <u>one of</u> <u>the</u>" learning activity options recognized by the" board. This is to clarify that a nurse licensee shall complete "one" and not a combination of the learning activity options.
- Page 5, lines 20-21, should be amended to delete the orientation of an employee as credit for precepting. The Board determined that since there are no "standards" specified, allowing a nurse to obtain continuing

competency credit for performing an orientation was not the same as precepting a nursing student.

- Page 6, lines 8-9, should be amended to specify the nursing research project must be an institution review board ("IRB") project. An IRB, also known as an independent ethics committee, ethical review board or research ethics board, is a committee that has been formally designated to approve, monitor, and review biomedical and behavioral research involving humans. The Board determined that clarifying the standard for the research project was necessary. The Board also determined that other evidence-based practice projects must first be pre-approved by the Board.
- Page 6, lines 14-16, should be amended to clarify that the development and conducting of a nursing education presentation should be hours that qualify to offer continuing education.

These proposed amendments will allow the Board to implement the continuing competency program without having to promulgate administrative rules for clarification.

Additionally, the Board has been engaged in productive discussions with the Center for Nursing about this bill and plans to continue those discussions at its next Board meeting on March 5, 2015.

SB735 SD1 RELATING TO CONTINUING EDUCATION FOR NURSES

Chair Baker, Vice Chair Taniguchi, and members of the Senate Committee on Commerce and Consumer Protection, thank you for this opportunity to provide testimony in strong support of this bill, SB735 SD1.

Addressing the needs and interests of the people of Hawai'i includes ensuring that quality health care is easily accessible to consumers throughout the State. Nurses are critical to the successful implementation of health care reform. Continuing competency plays a significant role in nursing professionals' ongoing development and for the betterment of the patients they serve. The individual nurse must embrace lifelong learning as an essential key to delivering safe high quality patient care.

The Hawai'i State Center for Nursing (HSCN) formed the Continuing Education Joint Advisory Committee (CEJAC) in accordance with SCR 167 SD2, SLH 2010, which determined that a continuing competency program (self-assessment, implementation of a personal learning plan, CE and subsequent reassessment) is preferable to simple CE program. Additionally, CEJAC concluded that continuing competency requirements may be implemented in the state without fiscal burden to nurses, their employers, or academic institutions. However, the HSCN also supports the legislature's finding that the Hawai'i nurse continuing competency program must be established in phases, beginning with learning activity requirements that support continuing competency in nursing.

Further, after continued discussions with our community partners, we respectfully ask that the CPN Committee consider making the following amendment to Page 3, Lines 15-21. Language under consideration is marked in bold:

If a licensee who graduated or completed pre-licensure requirements from an accredited nursing program more than twelve months but less than two years prior to the renewal date, the registered nurse or practical nurse licensee shall be required to obtain fifteen contact hours of continuing education, one semester credit of post-licensure academic education related to nursing practice from an accredited nursing program, completion of a boardrecognized nurse residency program, or other learning activity options from an approved provider recognized by the board prior to the first renewal period.

Therefore, the HSCN respectfully requests that SB735 SD1, pass unamended. We appreciate your continuing support of nursing in Hawai`i. Thank you for the opportunity to testify.

I would like to provide comments regarding SB 735, relating to nurses. I agree with the intent of this bill, and also with most of the learning activity options for continuing competency. I would recommend that your committee consider these suggestions as amendments to the bill: 1. The word "preceptor" needs to be defined, with specific standards laid out to quality an individual as a preceptor (page 6, line 1); 2. Require that any nursing research be approved by the Institutional Review Board, and lay out standards for what qualifies as an evidencebased practice project (page 6, lines 10-12); and 3. Require that nursing education presentations must meet certain defined standards, be approved as continuing education units, or presented at a nationally recognized forum (page 6, lines 16-18). Support for Nursing Competencies, SB735 2015 Hawaii State Legislature

I am writing to offer my support for SB735. The Hawaii State Center for Nursing created the Continuing Education Joint Advisory Committee (CEJAC) created by comprised of representation from the Hawai'i State Department of Commerce and Consumer Affairs (DCCA), Hawaii Board of Nursing (HBON), nursing academic institutions, professional organizations, employers, and the unions which represent nursing. This committee recommended:

- Development of a continuing competency program (CCP) for registered and practical nurses in Hawai'i
- Implementation of a CCP would have no fiscal impact on nurses, employers, or Hawai'i educational institutions.
- CCP requirements support the HBON, and DCCA's Professional and Vocational Licensing Division (PVLD) and Regulated Complaints Office (RICO) interest in and responsibility for consumer safety and ensuring that nurses practice safely and demonstrate competency throughout their career.

Nationally, 71% of Boards of Nursing require some level of continuing competency, with an overall increase in CCP requirements of 33% since 2010. The most common requirements include 30 contact hours of continuing education (CE), academic courses related to nursing, national certification in a nursing specialty, refresher courses, authoring publications, or giving nursing presentations.

Insuring nursing competency will benefit patients from all areas of Hawaii, both urban and rural. SB735 SD1 RELATING TO CONTINUING EDUCATION FOR NURSES

Chair Baker, Vice Chair Taniguchi, and members of the Senate Committee on Commerce and Consumer Protection, thank you for this opportunity to provide testimony in strong support of this bill, SB735 SD1.

Addressing the needs and interests of the people of Hawai'i includes ensuring that quality health care is easily accessible to consumers throughout the State. Nurses are critical to the successful implementation of health care reform. Continuing education plays a significant role in nursing professionals' ongoing development and for the betterment of the patients they serve. The individual nurse must embrace lifelong learning as an essential key to delivering safe high quality patient care.

The supports the Hawai'i State Center for Nursing's Continuing Education Joint Advisory Committee (CEJAC) determination that a continuing competency program (self-assessment, implementation of a personal learning plan, CE and subsequent reassessment) is preferable to simple CE program. Additionally, CEJAC determined that continuing competency requirements may be implemented in the state without fiscal burden to nurses, their employers, or academic institutions. However, the also supports the legislature's finding that the Hawai'i nurse continued competency program must be established in phases, beginning with learning activity requirements that support continuing competency in nursing.

Further, the supports exempting Hawai'i licensed registered nurses who:

- are licensed in Hawai`i as APRNs who maintain national certification;
- maintain current national certification from a recognized national certifying body in their practice role; or
- are first-time license renewal applicants whose initial license was issued less than twelve months prior to the renewal date.

Therefore, the respectfully requests that SB735 SD1, pass unamended. We appreciate your continuing support of nursing in Hawai'i. Thank you for the opportunity to testify.
