## S.B. 746 - RELATING TO CYBERSECURITY

The Hawaii Government Employees Association, AFSCME Local 152, AFL-CIO opposes a portion of Section 2 of S.B. 746 that exempts the Secretary position to the Cyber Security Coordinator from Chapter 76, Hawaii Revised Statutes. This particular type of exemption from civil service has become all too prevalent and is inconsistent with purpose and intent of Article XVI of the Hawaii State Constitution and Section 76-1 HRS.

While we understand the unique qualifications needed to recruit for a Cyber Security, Economic, Education and Infrastructure Coordinator, there is no legitimate reason for a clerical support position to be exempted from civil service. This position should be filled within the civil service system and the employee should be provided with the same employment protections as other clerical support staff throughout state government.

We appreciate the opportunity to oppose exempting the Secretary position from civil service, as contained in S.B. 746.
