The Department of Business, Economic Development, and Tourism (DBEDT) <u>supports</u> SB 75, SD 2, which requires the Department of Health to establish the Hawaii battery storage recycling task force to make recommendations for a workable recycling program for battery storage devices in Hawaii and the task force to submit interim and final reports to the legislature. The bill names the Hawaii State Energy Office, a Division of the Department of Business, Economic Development, and Tourism, as a member of the task force.

DBEDT is supportive of this measure as it is consistent with our energy policy directive of balancing technical, economic, environmental, and cultural considerations¹. As the adoption of battery storage increases in order to support the State's achievement of the 100 percent Renewable Portfolio Standard by 2045, it will be important for our State to be prepared with battery storage recycling programs to properly protect our environment.
