The Office of Hawaiian Affairs offers the following <u>COMMENTS</u> on SB786 SD1, which appropriates an unspecified amount of funds to be spent by the Department of Land and Natural Resources for the administration, operation, and outreach of the Aha Moku Advisory Committee.

The Advisory Committee has a commendable mission of advising the chairperson of the Board of Land and Natural Resources on such important matters as:

- Integrating indigenous resource management practices with Western management practices in each moku;
- Fostering the understanding and practical use of Native Hawaiian resource knowledge, methodology, and expertise; and
- Sustaining the state's marine, land, cultural, agricultural, and natural resources.

Although the Advisory Committee's mission and efforts benefit all who call Hawai'i home, OHA is currently the sole funder of the committee, and has kept it alive by an infusion of nearly \$250,000 in OHA trust funds. Funding from the state, as this measure proposes, is critically necessary for the Advisory Committee to continue to carry out its mission. OHA believes that it is appropriate for the state to resume funding this important and innovative approach to natural and cultural resource management.

Comments: I support this measure and its' intent to help communities address issues with the help of the DLNR. I joined the Aha Moku to represent my community of Hookena. Our organization was founded in 1998 and we helped establish the West Hawaii Fishery Management Area and the West Hawaii Fishery Council. Thus far the Aha Moku has had no impact on our community and there is now an appearance of "in fighting" and dissatisfaction with the Executive Director. This can and should be fixed but not by throwing money at it. I would like to see the money spent to reorganize the Aha Moku by setting clear a measurable goals and promulgating new administrative rules. That should be followed with more out reach to the communities that request assistance. The Aha Moku has not been successful in West Hawaii but it has been effective on other islands due largely to the leadership from those islands.

In **SUPPORT** of Senate Bill 786 SD 1 **Relating to the Aha Moku Advisory Committee**

Senate Bill 786 appropriates funds for the administration and operation of the Aha Moku Advisory Committee and for community outreach.

The Aha Moku System encompasses the eight main Hawaiian Islands and supports the traditional and generational knowledge of the people who are connected to each of the 43 moku and more than 500 ahupua'a. The system was restored by John Kaimikaua, a noted Moloka'i historian through translations of ancient oral chants from the 9th century, a time where sustainability and protection of resources ensured existence. It was a time where the focus of the people of the land was on survival. Those resource practices were handed down through the generations and many are still used today. The Aha Moku today is centered around sharing that knowledge with those who are now part of ahupua'a communities – the focus is on natural and cultural resource sustainability.

The purpose of the Aha Moku Advisory Committee, representatives of each of the eight main Hawaiian Islands is to be the liaison between their islands to the Chairman of the Board of Land and Natural Resources to whom recommendations in regards to resources may be made on behalf of their ahupua'a communities. This has been done successfully and reflected in the Legislative Report submitted each year in English and Hawaiian. An administrative structure that ensures this collaboration with the islands and the AMAC has been instigated along with a communications and reporting format.

However, organizing all of the ahupua'a so resource issues can be accurately addressed in each one is daunting because of budget restraints. The AMAC has only been in operation since June of 2013

and yet has completed many of the objectives listed in their strategic plan. This is reflected in the 2014 and 2015 legislative reports.

The AMAC is in the process of community outreach educational efforts on the benefits of the Aha Moku System in its relationship with DLNR, OHA and many other non-governmental agencies, Native Hawaiian organizations, groups and communities. It is open to the public and although is Native Hawaiian in nature, it focuses on protection and sustainability of Hawaii's unique and special ecosystem. Everyone now is a stakeholder in the fortification of our lands and oceans. Aha Moku is a strong partner in safeguarding our assets. However, we need the funding and support of the Legislature to ensure the protection of our wealth – the wealth of Hawaii, the irreplaceable natural and cultural resources that can be found nowhere else in the world.

We humbly ask that the Senate Ways and Means Committee pass SB 786 SD 1.

I am the Po'o for Kauai on the Aha Moku Advisory Committee. I support SB 786 that relates to the Aha Moku Advisory Committee for appropriating funds for the administrations and operational expenses and for the community education on Natural and Cultural resource management.

The Aha Moku bill unanimously was passed in 2012 by the legislature and has not yet been funded.

In realizing that this system empowers the people of an ahupua'a in resource and the cultural protection, the office of Hawaiian Affairs instead funded this problem completely. However, I feel that we cannot expect the Office of Hawaiian Affairs to continue to carry the responsibility in the appropriation for the Aha Moku by the legislature forever.

In creating this organization called "Hui Makaainana of Makana" of Haena, we still teach groups of Keiki on our island about the culture and resources and so we are fully supporting this bill and urge this legislature to consider this bill that we feel is very important in this 20th Century.

Now is the time to teach and malama the aina that our Kupuna taught me and without their funds who will share this knowledge that I have.

In closing I leave this testimony with a chant of Haena by my Great, great Tutu.

Ka Poli Laua'e

Hawn: Ka Poli Laua'e Ka'u Aloha English: The bosom of Laua'e is what I love Hawn: A Makana' Ho'i ae hi'i mai nei English: That Makana holds and embraces
