RELATING TO HIGH TECHNOLOGY

Senate Bill No. 887 authorizes, among other things, the issuance of special purpose revenue bonds (SPRB) to develop and implement an offshore high technology park and cable landing sites throughout the State.

The Department has comments on this bill. The High Technology Development Corporation (HTDC), a public body corporate and politic and an instrumentality and agency of the State, currently has the authority to issue revenue bonds. As Section 3 of the bill amends HTDC duties to include "... (6) Developing an offshore high technology park pursuant to Section 206M-C", it would be more appropriate for HTDC to issue revenue bonds for this project (as well as for other HTDC projects). While the HTDC has the general statutory authority to issue revenue bonds for their projects, they will require specific issuance and appropriation authority, such as the \$130,000,000 contemplated, for any such issuance. In addition, please note that the issuance of revenue bonds (and SPRBs) require, among other things, the project to generate sufficient revenues to pay debt service on the bonds.

The High Technology Development Corporation (HTDC) **supports the intent** of SB887 relating to establishing a board for offshore high technology park review within HTDC and issuance of special purpose revenue bonds to develop and implement an offshore high technology park and broadband cable landing sites throughout the state.

As part of HTDC's vision to create 80,000 new innovation jobs in Hawaii earning \$80,000 or more by 2030, HTDC supports initiatives aimed at improving Hawaii's reputation as a place for innovation and a place to do business and improving Hawaii's high speed broadband infrastructure.
