Chair Espero, Vice Chair Baker and Members of the Senate Committee on Public Safety, Intergovernmental and Military Affairs:

I am Brigadier General Arthur J. Logan, State Adjutant General and the Director of the Hawaii Emergency Management Agency. I am testifying in **SUPPORT** of Senate Bill 889.

This measure will authorize funding for a new Joint Emergency Management Center (JMEC). This new center would be a state-of-the-art emergency management facility providing opportunities for face-to-face and electronic collaboration between emergency management agencies and their public, private and non-profit partners. The facility must provide for training and meeting spaces that would serve as working spaces for our partners during emergency operations. The requirements for facility hardening, communications and backup systems, and self-sufficiency are paramount.

The State Department of Defense and the Hawaii Emergency Management Agency began working on a JMEC with their partners over two year ago. This working group addressed the concept and requirements. They are at the point of the process to identify possibly locations for the JMEC.

The Mililani Public Safety Tech Park is a location identified in Senate Bill 533. The Mililani location may not be best location for all partners. I ask you consider the following change in this bill.

<u>As written</u> – Section 1. The legislature finds that various public safety and emergency management agencies have expressed an interest to relocate or expand their facilities to one central location. The addition of a joint emergency management center at that central location will provide Hawai'i with the opportunity to bring together several essential agencies and organizations

<u>Proposed language</u> – Section 1. The legislature finds that various public safety and emergency management agencies have expressed an interest in developing a joint emergency management center to increase their collaboration and communication before, during and after disasters. The addition of a joint emergency management center at a central location will bring together several essential agencies and organizations to better protect the people of Hawai'i. This change will allow the site selection process to continue and insure our partners have input as to their site requirements. This will be a preplanning and feasibility study that determines who should be included, location, anticipated costs, and anticipated scope of the project.

I ask the members of this committee to vote in **SUPPORT** Senate Bill 889 with the change proposed.

Chair Espero, Vice Chair Baker and Members of the Committee.

I am Doug Mayne and I am the Administrator of the Hawaii Emergency Management Agency. I am testifying in **STRONG SUPPORT** to SB 889.

Senate Bill 889 authorizes funding for a badly needed Joint Emergency Management Center. Hawaii's current facility for central coordination in emergencies, the State Emergency Operations Center (EOC) at Diamond Head, is almost 100 years old and has only 800 square feet of operational space. This is inadequate for the purpose of a modern EOC, which must house hundreds of people responding collaboratively to disasters. Additionally, the structure of the State EOC, and its location inside Diamond Head Crater, make building additions or reconfiguration of the facility impossible.

During the response to Hurricane Iselle last summer we were forced to put key response staff in buildings outside Diamond Head Crater. The separation of staff restricted our ability to coordinate and communicate. Although the space issue did not severely impact our ability to respond to Hurricane Iselle, it could have if the impacts been more severe.

The State Department of Defense and the Hawaii Emergency Management Agency have been working for over two years on conducting outreach and planning activities with partners interested in pursuing a Joint Emergency Management Center (JEMC), including the City and County of Honolulu's Department of Emergency Management and the Federal Emergency Management Agency. There are a total of 13 local, state, federal, private sector and non-profit partners interested in occupying space in the JEMC. We have developed gross-order-of-magnitude requirements with the interested agencies and are at a point in the planning process where we need additional funding to explore land acquisition and to conduct detailed plan development.

Our goal is for a purpose-built, state-of-the-art emergency management facility that provides opportunity for close collaboration for emergency management and public safety partners both

on a day-to-day basis and during crises. This facility will need to be protected against both the physical threats from disasters and the increasing threats from cyberattacks. It will be completely self-contained and self-sufficient, including backup systems to ensure continued operations when completely cut off from utilities (water, power, phone and internet). It will also include dual-use space that will normally be used for training and education, but becomes an extension of the State Emergency Operations Center during an emergency. This will ensure the large staff that responds during more damaging disasters can be accommodated within the building.

SB 533 seems to indicate that the JEMC is to be built at the Mililani Public Safety Tech Park. Since this location might not be optimal for all partners, please consider changing the language as proposed below:

<u>As written</u> – Section 1. The legislature finds that various public safety and emergency management agencies have expressed an interest to relocate or expand their facilities to one central location. The addition of a joint emergency management center at that central location will provide Hawai'i with the opportunity to bring together several essential agencies and organizations.

**Proposed language** – Section 1. The legislature finds that various public safety and emergency management agencies have expressed an interest in developing a joint emergency management center to increase their collaboration and communication before, during and after disasters. The addition of a joint emergency management center at a central location will bring together several essential agencies and organizations to better protect the people of Hawai'i.

I believe the proposed changes will allow us to ensure that all essential partners remain part of the JEMC by building it in a location that works for all.
