PURPOSE: The purpose of this bill is to appropriate funds to the Department of Human

Services to operate an interpreter referral service for the deaf and hard of hearing community.

DEPARTMENT'S POSITION: The Department of Human Services (DHS), Division of Vocational Rehabilitation (DVR) supports the intent and purpose of S.B. 962, provided that passage of the measure does not replace or adversely impact priorities indicated in the Executive Budget. However, the DVR provides the following comments.

The DVR has provided interpreter referral services for the community for approximately thirty years via a request for proposal. Currently, the referral service is completely state funded with funds from the DVR base budget. However, using funds from the DVR base budget to provide the larger community service, has the negative effect of reducing the overall amount of funds available for the disabled population that uses DVR services. This is the consequence because the state funds used for the interpreter service are no longer available as part of the state's match towards federal matching funds. It is difficult for the DHS to continue this larger community service; ideally it would be more appropriate to have specific funding to continue to provide the service to non-vocational rehabilitation related requests. Currently, the DVR uses approximately \$80,000 of general funds for these contracted services; the current vendor estimates that in the future the program will cost at least \$90,000. However, while a more expansive interpreter service continues to be a long term goal of the DVR, the expansion of this service at this time is not within the priorities set forth in the Executive Budget.

TESTIMONY TO THE SENATE COMMITTEES ON HUMAN SERVICES AND HOUSING

Senate Bill 962 - Relating to Interpreter Referral Services

The Disability and Communication Access Board (DCAB) is a statewide Governorappointed Board with a majority of its members being persons with disabilities or family members. The Board's mission is to advocate and promote full inclusion, independence, equal access, and quality of life for persons with disabilities in society. This testimony represents a position voted upon by the Legislative Committee of the Board.

DCAB supports Senate Bill 962 that makes an appropriation to the Department of Human Services (DHS) for an American Sign Language interpreter referral service for public and private entities serving individuals who are not participants of the DHS, Division of Vocational Rehabilitation (DVR).

Currently, the DHS, DVR contracts for an interpreter referral service using general funds of \$80,000 per year for each year of the biennium. The services statewide are contracted out to a private agency to provide these services for deaf and hard of hearing participants, both DVR and non-DVR participants. DCAB notes that the interpreter referral contract underwrites the cost of finding and placing an interpreter, not the hourly cost of the interpreter's services. This cost is borne by the agency requesting the interpreter. DVR has estimated that approximately half of the total number of people served annually are DVR participants. DVR's mandate is to assist people with disabilities find and maintain employment; therefore, it is going beyond federal requirements by using DVR funds to pay for non-DVR client services. The appropriation being requested in this bill is to continue to offer the whole community interpreter referral services, and allow DVR to use federal matching funds to offer DVR participants other needed services.

DCAB defers to the Department of Human Services, Division of Vocational Rehabilitation regarding the amount of funding needed.
