In consideration of S.B. 975
RELATING TO THE RENTAL HOUSING TRUST FUND.

HHFDC <u>supports</u> S.B. 975, which adds a new secondary preference for Rental Housing Trust Fund project applicants that have received awards of non-volume cap Low-Income Housing Tax Credit and Hula Mae Multifamily revenue bonds. We believe this will provide additional incentives for the development of rental projects serving lower income households.

Under current law, affordable rental projects that have been allocated volume cap LIHTCs have first priority for RHTF awards to ensure that the State of Hawaii's per capita allocation of nine percent LIHTCs is fully utilized every year. All other eligible projects compete for any remaining available RHTF funds.
