TESTIMONY OF THE OFFICE OF THE LIEUTENANT GOVERNOR TO THE HOUSE COMMITTEE ON HUMAN SERVICES

SENATE BILL 980, SENATE DRAFT 1

Relating to Afterschool Programs

March 17, 2015

Chair Morikawa, Vice Chair Kobayashi, and members of the committee, thank you for the opportunity to provide testimony in <u>strong support</u> of Senate Bill 980, Senate Draft 1. This measure seeks to establish a program that will provide after-school programs in public middle and intermediate schools throughout the state of Hawaii. R.E.A.C.H., which is an acronym for resources for enrichment, athletics, culture and health is an initiative aimed at keeping Hawaii's youth engaged and excited about learning during the after-school hours so they can stay on the right path towards high school graduation and be better prepared for future success. Programs offered will be from three general categories: academic enrichment, arts and culture, and athletics.

The middle school years are a critical time in a child's life where disengagement can start to take hold. The stakes of disengagement are high. Once students disconnect, recruitment and retention programs require stronger, more persistent outreach and more long-term participation. Juvenile crime, drug rehabilitation, counseling and other forms of intervention result in higher costs to taxpayers. The bottom line is that after-school programs keep kids on the path that leads to high school, college, career, and ultimately, a better quality of life. This bill addresses a critical need for Hawaii's middle school students.

This bill establishes new sections under Chapter 352D, Hawaii Revised Statutes, to create the R.E.A.C.H. program in the Office of Youth Services in order to provide a standardized framework for after-school programs offered in public middle/intermediate schools. The program would be administered by the Office of Youth Services. Last year, the Legislature provided funding to support the R.E.A.C.H. program for FY15.

Eleven public middle/intermediate schools have thus far benefited from FY15 funding, including one public charter school.

Provisions in the bill allow for participation fees to be established which would serve to supplement the cost of administering and operating the program and enhance the sustainability of R.E.A.C.H. Additionally, the Office of Youth Services is dedicated to creating opportunities for the youth to develop competencies that foster resiliency and enable them to achieve a successful transition to young adulthood. The objectives of the R.E.A.C.H. initiative are wholly aligned with the objectives of the Office of Youth Services. Over the past year, our office has worked collaboratively with the Department of Education (DOE), the Office of Youth Services, and a working group of middle school principals and DOE administrators to develop both the pilot project and the long-term structure for R.E.A.C.H. In addition to the working group, an Advisory Board comprised of well-known community leaders committed to improving outcomes for Hawaii's youth was also established to provide insight, guidance, and support for this important initiative.

In conclusion, we would like to thank the legislature for its support with the pilot project and initial funding for FY15. We hope that we can continue to build upon what has been started. The Office of the Lieutenant Governor **strongly supports** SB 980 and respectfully urges the passage of this bill. Thank you for the opportunity to testify. TO:

PURPOSE: The purpose of SB 980, SD1, Relating to Afterschool Programs is to establish the resources for enrichment, athletics, culture and health (R.E.A.C.H.) program in the Office of Youth Services (OYS) to provide a standardized framework and funding for after-schools programs in public middle and intermediate schools. The initiative from the Lieutenant Governor's Office also:

- establishes a special fund to receive fees and other moneys to supplement the costs of administering and operating the program
- appropriates funds for establishing the program

OFFICE'S POSITION: OYS strongly supports SB 980, SD1, Relating to Afterschool Programs.

OYS recommends the following amendment be added to allow rulemaking authority to Section 2 of the bill. The purpose of the additional wording is to allow OYS to set participation fees and to establish program requirements by adopting administrative rules pursuant to chapter 91, Hawaii Revised Statutes. The new section 352D-B(c), on page 7, line 1, subsection (c) would read (new material underscored):

"(c) <u>Pursuant to chapter 91,</u> the office may establish <u>program requirements and</u> participation fees or other charges to be assessed to each student for the cost of administering

and operating the R.E.A.C.H. program. The revenues from those fees shall be deposited into the R.E.A.C.H. program special fund to be used to supplement the costs of administering and operating the program. "

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS WITH AMENDMENTS</u> SB980 SD1, which would establish a Resources for Enrichment, Athletics, Culture and Health (R.E.A.C.H.) Program within the Office of Youth Services.

The R.E.A.C.H. Initiative proposes to fill the current void of after-school activities for public middle and intermediate school students with an organizational framework, which will ensure that our 'ōpio at this highly impressionable and vulnerable age receive the kind of positive support and educational stimulation to keep them motivated and engaged in academic enrichment, arts and culture, and athletics.

In recognition of the critical need to create after-school programming for our 'ōpio, the OHA Board of Trustees on December 5, 2013 approved an allocation of \$75,000 to establish R.E.A.C.H. programs at Moloka'i Middle School and Hāna High and Elementary School.

OHA respectfully requests that SB980 SD1 be amended, to make it clear that the R.E.A.C.H. program may also serve public charter schools as well as Department of Education schools. A definition providing such clarity was included in this measure's House companion, HB397 HD2, which did not pass out of the House. Accordingly, OHA asks that page 8, lines 10-15, of this measure be amended to read as follows:

SECTION 3. Section 352D-3, Hawaii Revised Statutes, is

amended by adding new definitions to be appropriately

inserted and to read as follows:

""Public schools" means all academic and noncollege

type schools established and maintained by the department

and charter schools governed by chapter 302D.

"R.E.A.C.H. program" means the resources for enrichment, athletics, culture, and health program established pursuant to section 352D-A."

Therefore, OHA urges the Committee to **PASS WITH AMENDMENTS** SB980 SD1. Mahalo nui for the opportunity to testify on this measure.

Dear Chair Morikawa, Vice Chair Kobayashi, and members of the committee:

Thank you for the opportunity to provide testimony in *strong support* of Senate Bill 980, Senate Draft 1.

I am Tom Apple, Professor of Chemistry and former Chancellor of the University of Hawai'i at Mānoa and also President of a non-profit organization called REACH Out Hawai'i which was established a little over a year ago to support the state's R.E.A.C.H. initiative of developing a comprehensive framework for afterschool programs for public middle and intermediate schools throughout the state.

Our mission at REACH Out Hawai'i is to leverage resources from the private and public sector to help build a sustainable funding base for high quality programs that keep our kids engaged in learning so they can succeed in school and in life.

As an active Professor of Chemistry and the former Chancellor of the state's flagship public institution for higher education, I have a personal stake in promoting and supporting R.E.A.C.H. as middle schools are the pipeline to higher education. We are all far too familiar with the need to increase both our high school graduation and college going rates. In order to affect this, we need to place more attention at the middle school level and this bill will achieve this. The need to leverage the power of expanded learning opportunities after school has never been greater as our world has become increasingly complex. We have come to realize that instructional hours alone cannot support all of the learning needs required to adequately prepare Hawai'i's youth not only for higher education, but for a career in the 21 st century and a globally competitive job market.

We *strongly support* SB 980, SD 1 and respectfully urge the passage of this bill. The bill addresses a critical need for Hawai'i's middle school students.
