TESTIMONY OF THE OFFICE OF THE LIEUTENANT GOVERNOR TO THE SENATE COMMITTEE ON HUMAN SERVICES AND HOUSING

SENATE BILL NO. 980

Relating to After-School Programs

February 3, 2015

Chair Chun Oakland, Vice Chair Green, and members of the committee, thank you for the opportunity to provide testimony in <u>support</u> of Senate Bill No. (SB) 980. This measure seeks to establish a program that will provide after-school programs in public middle and intermediate schools throughout the state of Hawaii. R.E.A.C.H., which is an acronym for resources for enrichment, athletics, culture and health is an initiative aimed at keeping Hawaii's youth engaged and excited about learning during the after-school hours so they can stay on the right path towards high school graduation and be better prepared for future success. Programs offered will be from three general categories: academic enrichment, arts and culture, and athletics.

The middle school years are a critical time in a child's life where disengagement can start to take hold. The stakes of disengagement are high. Once students disconnect, recruitment and retention programs require stronger, more persistent outreach and more long-term participation. Juvenile crime, drug rehabilitation, counseling and other forms of intervention result in higher costs to taxpayers. The bottom line is that after-school programs keep kids on the path that leads to high school, college, career, and ultimately, a better quality of life. This bill addresses a critical need for Hawaii's middle school students.

This bill establishes new sections under Chapter 352D, Hawaii Revised Statutes, to create the R.E.A.C.H. program in the Office of Youth Services in order to provide a standardized framework for after-school programs offered in public middle/intermediate schools. The program would be administered by the Office of Youth Services. Last year, the Legislature provided funding to support the R.E.A.C.H. program for FY15.

Eleven public middle/intermediate schools have thus far benefited from FY15 funding, including one public charter school.

Provisions in the bill allow for participation fees to be established which would serve to supplement the cost of administering and operating the program and enhance the sustainability of R.E.A.C.H. Additionally, the Office of Youth Services is dedicated to creating opportunities for the youth to develop competencies that foster resiliency and enable them to achieve a successful transition to young adulthood. The objectives of the R.E.A.C.H. initiative are wholly aligned with the objectives of the Office of Youth Services. Over the past year, our office has worked collaboratively with the Department of Education (DOE), the Office of Youth Services, and a working group of middle school principals and DOE administrators to develop both the pilot project and the long-term structure for R.E.A.C.H. In addition to the working group, an Advisory Board comprised of well-known community leaders committed to improving outcomes for Hawaii's youth was also established to provide insight, guidance, and support for this important initiative.

In conclusion, we would like to thank the legislature for its support with the pilot project and initial funding for a R.E.A.C.H. program for FY15. We hope that we can continue to build upon what has been started. The Office of the Lieutenant Governor *strongly supports* SB 980 and respectfully urges the passage of this bill. PURPOSE: The purpose of SB 980, Relating to Youth, is to establish the resources for enrichment, athletics, culture and health (R.E.A.C.H.) program in the Office of Youth Services (OYS) to provide a standardized framework and funding for after-schools programs in public middle and intermediate schools. The initiative from the Lieutenant Governor's Office also:

- establishes a revolving fund to receive fees and other moneys to supplement the costs of administering and operating the program
- appropriates funds for establishing the program

OFFICE'S POSITION: OYS strongly supports SB 980, Relating to Youth. There are several common denominators in the lives of our at-risk youth, including but not limited to: a lack of connectedness, a sense of not belonging, and failure in school. These factors all lead to poor decision making – which is evidenced by the fact that middle school aged children represent nearly ½ of all first time juvenile arrests in our state.

Providing quality after school programming for middle schoolers through the R.E.A.C.H. program will address those very issues – relationships, connections and school engagement will positively impact school attendance and success, and is a critical prevention tool in the juvenile justice arena. Therefore, this bill is one of the Keiki Caucus' priorities.

This year, I have been a REACH Program coordinator at Waikoloa Middle School on Hawaii Island. Many of our student parents (often both) work at the surrounding resorts. Particularly during tourist season, our parents work long hours and often not available afterschool for our students. Our school is in a remote area of the island, where there are no buses to take the students to afterschool resources. We are also a title I school, so many student families do not have the funds to support afterschool activities. Our school is often considered "the community Center". Having access to REACH funds, makes a significant differences in their lives. In tracking their ongoing grades and behaviors at school, these students have done very well.

Through our current REACH funded program, our students have been able to travel around the island and experience many activities that would never have been available to them. Some of our students will be traveling to Honolulu to see museums which will be for many, their first museum visit, first flight, first time seeing a large city.

Teachers and community members have put together the existing programs and give so much more, supporting additional tutoring/homework time. I know the students feel very supported by teachers and community members.

I encourage continued funding of the REACH program. We have no other venue like this that does so much for our students outside of their regular school day.
