IN THE PUBLIC EDUCATION SYSTEM.

Purpose of Resolution:

Department's Position:

Assessments play an important role in teaching and learning. Results from assessments provide important information about students' learning that helps educators focus instruction on the skills that students need to master in order to become college and career ready. However, time spent testing must be balanced with the critical importance of instruction and student supports.

The Department has already taken action to achieve a more balanced approach to testing and instructional time. In school year 2014-2015, the Department performed a review of all of the assessments required by the state and federal government. As a result, the state requirements for testing students were reduced, including eliminating requirements for tests that were deemed redundant.

The recently enacted federal Every Student Succeeds Act (ESSA) recognizes the importance of measuring academic achievement and the need for meeting certain standards of validity and reliability. Hawaii currently administers just one test above the minimum required under the law. Schools are also empowered to implement additional assessments they may deem necessary for their individual curriculums.

The Department acknowledges the concerns raised in the resolution and has already taken action in reducing the number of standardized assessments where possible and is exploring alternative measures of student achievement as well as multiple measures beyond standardized testing. As such, the Department feels that this resolution is not necessary.
