My name is Nicole Vannatta and I am a member of the board of directors for The Wahiawa Center for Community Health. I support this measure.

As a board member, I have made a commitment to make the community healthier. You don't have to spend a lot time in Wahiawa to understand there is a significant shortage of healthcare resources. When the WCCH opens its doors, we hope to quickly make an impact on the community by making healthcare services available to all.

I currently serve on the Education committee. A short time ago, the WCCH was afforded the privilege of meeting with a number of Wahiawa school officials. They shared their stories and challenges with us, and helped us identify ways that we might be able to support the schools in the future. I would like to share one story with you today.

There was a young girl who was chronically absent from school. When the school contacted her mother to find out why she was chronically absent, they found out that it was due to her mother's illness. The Mom had health issues that required her to routinely seek medical care. The healthcare services that were available to her were in town. She did not drive, and therefore relied on the bus. The bus trip to and from town took several hours, and on days that she had to travel to town for doctor's visits, she could not guarantee that she would be home in time to meet her daughter after school. She lived in an unsafe neighborhood, and did not want her daughter to come home alone, so



she would pull her daughter out of school for the entire day when she needed to seek medical services in town. By making healthcare more accessible, this woman would not have to take a lengthy bus ride to access healthcare resources, and her daughter would not need to miss school.

The Wahiawa Center for Community Health will positively impact the lives of Wahiawa residents by offering comprehensive, accessible, affordable, culturally sensitive health care. We humbly ask you to support us as we take the last few steps towards opening the health center doors.

Because transportation is an issue in our rural community of Wahiawa and because of our lack of physicians in Wahiawa, many spend hours in public transportation to obtain healthcare outside of Wahiawa. The traffic situation out of Wahiawa to outside providers also creates extensive time for our families to get to a physician. This creates an undue burden on many families.

According to community health assessments that we ourselves completed, a high percentage of our community members suffer from some form of the top five chronic



health conditions, which could be controlled with help from a primary care network in Wahiawa.

The community is proud of its community hospital, the Wahiawa General Hospital, but with its limited resources, preventable and non-emergency visits are draining its limited resources and these services have proven to be better served at a primary, health center setting.

PLEASE pass SCR 25 so that the message of healthcare needs in Wahiawa becomes an issue that will gain public support.

As a rural community, we are seeing a high demand for youth health services. The need of consistent primary care closer to home, behavioral counseling and education will provide our youth with the quality of life they so deserve.

Wahiawa is facing many challenges as we transition into a more diverse community. I'm especially concerned about our youth. There are currently 4 students that I know of at Wahiawa Middle School that are pregnant. There are substantial behavioral issues, absenteeism and with the inadequate number of primary care clinicians practicing in Wahiawa this trend will continue. According to the numerous survey's completed, Wahiawa are underprivileged and underserved, therefore It is imperative that we bring in the Wahiawa Center for Community Health to our community to provide the much needed primary health care services.

At full operational capacity, the Wahiawa Center for Community Health's services will provide the nessary primary care, including pediatrics, obstetrics, gynecology, behavior health, oral health care, care coordination, and on-site pharmacy services. I strongly feel, having access to a community health facility closer to home is viable for a healthy community and is in our best interest.

It is without reservation, therefore, that I support WCCH's efforts to establish a Federally Qualified Health Center for our Wahiawa and surrounding communities.

- As a board member, I have made a commitment to make our community healthier. My commitment is to the children and families of Wahiawa and join in a concerted effort to revitalize the Wahiawa community. It begins with promoting a "healthy" community.
- As a born and raised third generation resident of Wahiawa, I have seen physicians retire or otherwise leave our community leaving my neighbors without access to healthcare. As a result, access to healthcare is a problem for our families. Eighty percent of our children receive free or reduced lunch in Wahiawa public schools. Resources are limited. They do not have the financial resources to travel and access quality healthcare or are not accepted by physicians that do not accept Medicaid recipients.
