Outrigger Hotels is in opposition to these resolutions, because working under previously enacted statues, the Department of Land & Natural Resources (DNLR) is currently meeting with the hotel operators, as well as the beach operators to develop beach use guidelines for Waikiki Beach.

These guidelines are in draft forms and should be allow to be completed. The implementation of SCR 53/SR 27 might be a little premature, because having DNLR developing guidelines will help them, in their limited resources, bring some resemblance of order to Waikiki Beach.
