My testimony is on behalf of the 442 members of the American Association of University Women (AAUW) in Hawaii, who list choice and women's reproductive health as important current concerns. My testimony is informed by my experiences at the University of Hawaii at Manoa, where I hear wonderful stories from students about the health services and education provided by Hawaii Planned Parenthood. Student conversations of this type are often prompted by their attendance in my gender violence course at UH-M, where I encourage community involvement and activism.

The surprising issue about these comments is that politicians at high levels of state and federal government in the USA do not pay attention to young people's approval of Planned Parenthood, combined with their high need of the clinical services provided by the organization. These students are the politicians and voters of the future.

In this regard, I am thankful that I live in Hawaii, where most senators and representatives are supportive of Planned Parenthood. Given, the high number of political attacks against Planned Parenthood nationally and across the states, and the increasing frequency of domestic terrorism perpetrated against mainland clinics, it is important for legislators in Hawaii to proclaim their support of Hawaii Planned Parenthood, and their intolerance of violence against the organization and its patients.

Mahalo for the opportunity to testify. I am Walter Yoshimitsu, the executive director of the Hawaii Catholic Conference which is the public policy voice of the Roman Catholic Church in the State of Hawaii. Given the scientific fact that a human life begins at conception, the only moral norm needed to understand the Church's opposition to abortion is the principle that each and every human life has inherent dignity, and thus must be treated with the respect due to a human person. We simply cannot celebrate an organization that promotes and profits from the taking of an innocent life.

In 2010, Planned Parenthood Federation of American (PPFA) announced that by 2013 every affiliate must have one or more clinics that perform abortions on-siteⁱ. Planned Parenthood provides 16 times more abortions than birth-oriented services.

While PPFA says abortions make up only 3% of its services, this is misleading. PPFA's annual report for 2014-2015 indicates that it served 2.7 million patients (women and men) and performed 327,653 abortions, indicating that 12% of everyone entering a Planned Parenthood clinic receives an abortion. And PPFA provided only 18,684 "prenatal services" and 1,880 referrals for adoptions at other agencies. So 94% of its services for pregnant women are abortions, outnumbering other options 16 to 1ⁱⁱ.

Promoting life from conception until natural death is the foundation for the Church's social doctrine, including its teachings on war, the use of capital punishment, euthanasia, health care, poverty and immigration. Please defer this resolution. Mahalo for the opportunity to testify.

1. The measure states, "WHEREAS, since 1993, there have been eleven murders of individuals associated with abortion care. . ." My heart is saddened by the loss of each one of these 11 individuals. Each life had value. Each of those 11 persons had a future ahead of them that was cut off, terminated. I am thankful to hear that Planned Parenthood values the lives of these 11 individuals.

Every year, Planned Parenthood performs 300,000+ abortions. My heart is saddened by the loss of each one of these 300,000+ individuals (approx. 6,500,000+ since 1993). Each life had value. Each of those 6,500,000+ persons had a future ahead of them that was cut off, terminated.

Why isn't Planned Parenthood (and our State legislature) denouncing the violence against the staggering number of keiki destroyed through abortion every year? Abortion is extreme violence as a child is torn limb from limb and sucked out of his/her Mom's womb. Let all of us apply a consistent standard to the value of every life. Your life, my life, the lives of the 11 individuals murdered, lives of the unborn, because all of these lives began inside of a Mother's womb.

Taking the lives of innocent keiki does not sound like "providing high-quality, affordable health care in Hawaii." Why would we "celebrate Planned Parenthood?" Why would our great State affirm Planned Parenthood?

2. The measure states, "WHEREAS, Planned Parenthood offers cancer screenings, pregnancy testing and counseling, testing and treatment for sexually transmitted infections, <u>comprehensive sexual health education</u>, preventive health care services, birth control for men and women, emergency contraception, and abortion services; and..." I am thankful for any care that Planned Parenthood does provide. When you take time to research Planned Parenthood what you largely find, is the opposite. Planned Parenthood is driven by the multibillion dollar abortion industry. The services they provide are paid for in dollars, either from the government or payment for the service itself. Abby Johnson, who used to work for Planned Parenthood and even was named the Planned Parenthood worker of the year, validates what I am saying here. Read any of her material online.

Comprehensive Sex Education (CSE) is what Planned Parenthood has pushed into our Hawai'i D.O.E. schools. Four of the five B.O.E. approved sex ed curriculums are CSE based. CSE has proven to sexualize our keiki, encourage them to become more sexually active, begin experiencing sex at an earlier age and more. All of these consequences put our keiki at greater physical, psychological, emotional, relational, and spiritual risk. This is "sexual health education" that our great State should not affirm. We need to recognize that Planned Parenthood pushes CSE because it will fuel their "services" and make them more money. Violence for the cause of greed.

RE: Opposition to SR56 and SCR85 Regarding Planned Parenthood

We oppose these resolutions because they misrepresent Planned Parenthood as a "trusted health care provider". Planned Parenthood is the nation's largest abortion provider and has been plagued by scandal and abuse. Although it advertises itself as an organization promoting health for women and families, this politically well-connected abortion industry invests much of its resources in obtaining tax dollars to support their number one product: abortion, not health services. SCR 85 and SR 56 rightly denounces the violence towards abortion providers but fails to mention the atrocity of a death toll of over 3,000 babies killed daily by abortion and over 57 million since 1973.

Planned Parenthood preys on women when they are fragile and destroys young human life using inhumane procedures. If more people viewed an abortion, they would be writing the legislature demanding the end of this barbaric practice. The violence of the abortion procedure is what must be abhorred and discontinued. Planned Parenthood of Hawaii should be closed, rather than honored.

Planned Parenthood as a so-called "non-profit" giant receives over \$500 million annually from taxpayers and has used much of these dollars to offset enormous

salaries, campaign and advocacy efforts. This non-profit managed to have excess funds of \$127 million in 2014 with audit reports and admissions by former employees detailing a pattern of misuse of funds by some State Planned Parenthood affiliates. Polls also report that 72 percent of Americans do not want their tax dollars to support abortion, the taking of innocent, unborn babies.

There are plenty of facilities that can provide healthcare to women. We neither need nor want Planned Parenthood in our State and we especially don't want our tax dollars funding this organization.

Planned Parenthood isn't about healthcare <u>it is about abortion and profit</u>. The recent videos that exposed Planned Parenthood's <u>harvesting and selling of aborted baby</u> parts were shameful and should result in the prosecution of senior Planned Parenthood leadership.

Women are led to believe that contraceptives that may be provided by Planned Parenthood will enable them to have sexual relations without consequences. However, these contraceptives often fail. Many women who have an unplanned pregnancy <u>were using a contraceptive</u>. Individuals who use <u>condoms distributed by Planned Parenthood should know that Planned Parenthood</u> <u>condoms were found to have the highest failure rate</u>. Women and men who use Planned Parenthood products should beware.

Planned Parenthood prescribes oral contraceptives even though it is well known that oral contraceptives have been found to be a <u>Class 1 carcinogen</u> and there are <u>dangerous side effects</u>. Other carcinogens such as tobacco products are discouraged and sometimes banned. It is time to alert women that many products advocated by Planned Parenthood actually endanger their health. Study after study shows that abortion is closely linked to the presence of breast cancer. Numerous studies validate this cancer link which should be compelling enough to end the practice of this harmful procedure.

Resolutions SCR 85 & SR 56 is an affront to human rights and women's dignity.

Vote NO for both SR56 and SCR85.

I am a mother, grandmother, registered nurse and health advocate. I strongly oppose SCR 85 SD1. This resolution appears to misrepresent Planned Parenthood as a "trusted health care provider". Planned Parenthood is the nation's largest abortion provider and has been plagued by scandal and abuse. Although it advertises itself as an organization promoting health for women and families, this politically well-connected abortion industry invests much of its resources in obtaining tax dollars to support their number one product: abortion, not health services. SCR 85 rightly denounces the violence towards abortion providers, but fails to mention the atrocity of a death toll of over 3,000 babies killed daily by abortion and over 57 million since 1973.

SCR 85 suggests that the "series of manipulated and misleading videos" along with "politically motivated and misguided investigations have failed to reveal any wrongdoing by Planned Parenthood".
