PSD is currently working with cultural practitioners across the State to provide Native Hawaiian programming for Hawaii's incarcerated population. It should be noted that it has been a challenging task to find program/service providers willing to commit to a set schedule to provide consistent host culture programming within a correctional system.

The Puuhonua concept is one that has yet to be established and vetted for programming viability and application of evidence-based standards, as recommended by the Justice Reinvestment Initiative.

The Department of Public Safety welcomes all input allowing practitioners to provide a program syllabus outlining in what form(s) an implemented Puuhonua would take.

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> SCR97, which would encourage the creation of a comprehensive program to facilitate the continued rehabilitation and successful reentry of convicted offenders who have paid off their debt to society.

To address the overrepresentation of Native Hawaiians in the criminal justice system,¹ OHA has long supported the integration of culturally-based models to better rehabilitate pa'ahao, reconcile them with their 'ohana and communities, and reduce recidivism. The Native Hawaiian Justice Task Force has similarly encouraged the exploration of options to address systemic issues in the criminal justice system, such as by supporting indigenous models of healing, and bolstering reintegration programs and services.² In this regard, OHA agrees that a stronger network of support will better ensure that reintegrating pa'ahao can access critically-needed housing, healthcare, education, and employment resources. Moreover, OHA agrees that culturally-based support services may best aid formerly incarcerated pa'ahao in reconnecting with their culture, 'ohana, and community, increasing their chances of successfully reintegrating with and becoming productive members of society.

Accordingly, OHA believes that this resolution may help to establish a culturally-based support network, which could significantly alleviate the disproportionate burden of the criminal justice system on the Native Hawaiian community. OHA notes that the cultural concept of pu'uhonua as a "healing place" does not necessitate a physical space, but does imply some degree of constancy. Thus, the permanent programming this resolution contemplates could provide our formerly incarcerated pa'ahao with a stable, meaningful, and culturally-informed opportunity for true healing and lasting rehabilitation.

Therefore, OHA urges the Committee to **PASS** SCR97. Mahalo nui loa for the opportunity to testify on this measure.
