## TESTIMONY TO THE SENATE COMMITTEE ON PUBLIC SAFETY, INTERGOVERNMENTAL, AND MILITARY AFFAIRS

Senate Concurrent Resolution 61/Senate Resolution 33 – Encouraging the Department of Education to Promote Increased Participation by Schools in the Community Emergency Response Team Program

The Disability and Communication Access Board (DCAB) supports Senate Concurrent Resolution 61 and Senate Resolution 33 - Encouraging the Department of Education to Promote Increased Participation by Schools in the Community Emergency Response Team Program.

The Community Emergency Response Team (CERT) program is administered by the County Department of Emergency Management and Civil Defense agencies and offered to youth, between the ages of fourteen and eighteen, accompanied by family members or guardians. It is always positive to train youth in emergency preparedness, because what is learned in school will carry over into the student's adult life and create community resilience.

A DCAB staff member completed the CERT program in 2014 and notes that the class included teenagers with their parents. As an agency, DCAB also encourages people with disabilities (including students with disabilities) to participate in the CERT program to learn about personal awareness. We support all efforts to educate the public, including students with disabilities, to become involved and learn emergency readiness skills and then volunteer during a disaster. The general public usually does not consider that people with disabilities can assist others during an emergency. However, by including people with disabilities and others with access and functional needs in the CERT program, we begin to address the whole community by teaching personal responsibilities and preparing for emergencies through community education.
