This project's objectives are: a) to serve as an umbrella for ethnic radio stations like KNDI 1270 AM, KZOO 1210 AM, and KREA 1540 AM and other stations or media that can continue to effectively reach out to target populations via the proven mechanism of regular ethnic radio programs, b) expand reach through other mechanisms such as community gathering activities, print media, and television, and c) stabilize and increase sustainability of operations.
- 3. The public purpose and need to be served; Many Federal and State projects are required to be "language accessible" to fulfill Title VI, Civil Rights Act of 1964. Similarly, in 2006, the Hawaii State Legislature passed Act 290, Language Access to improve state and state funded services to immigrants of limited English proficiency.


